The Farmers Alliance of Nebrusks. met last week in Hastings in annual convention, to elect new officers, dissuss matters connected with the good of the order, and take such action as the times and the needs of the people sall for. The strong representative men in attendance, men of prominence from every part of the state, and the work they did, showed renewed zeal and prophesied a great revival of interest la Alliance work throughout the state. The Alliance is in purpose and possibilities the grandest of brotherhoods, and will not be allowed to die till its life work, the social education and in-Austrial emancipation of the farmers. has been accomplished.

MORNING SESSION, JANUARY 2.

Meeting called to order at 10:30 A. M. by President Powers. In the absence of Chaplain Snyder, prayer was then offered by Senator Dale. A. N. Housel of Lancaster was appointed door keeper in absence of Jno. Shay, regular door keeper. J. T. Kellie of Kearney was also appointed as assistant door keeper, and W. F. Wright as steward in the absence of such officers. The following were appointed as committee on credentials: Felton of Nuckolls, Leonard of Lancaster, and Borders of Buffalo. Then followed a general discussion from Alliance Manual. Topic, "Wealth and Money." After which recess was taken until 1:30.

AFTERNOON SESSION.

Meeting called to order at 1:30 by President Powers. We, the members of the state alliance of Nebraska, in convention assembled do hereby pledge ourselves anew to the principles of our order and our best endeavors to the reorganization and up-

ouilding of the same. Recognizing the deplorable condition of the agriculturist, the mechanic, the day laborer and the business man of our country, we demand of our representa-tives in congress some legislation for immediate reilef.

And recognizing that the question of money or flasnes is the all important question which affects the interest of every citizen, we demand the free coin-age of both gold and silver, without discrimination, at a ratio of 16 to 1, and in addition the issuing of non-interes-bearing treasury notes direct to the people, based upon the credit of the enure nation, without the intervention of banks, and said money shall be put into circulation through a system of government banks, thereby affording to hold-ers of moncy a safe piace of deposit, which we believe would result in the immediate restoration of confidence is the business world and make panics an

We favor the enactment of a law prohibiting alien ownership of hand and the preserving of all public lands for

We believe that the only solution of the transportation question is the government ownership and operation of all climate corrections facilities by which all wide work was commerce is carried on, and all products O street.

ganizations of the nation for their advanced steps in the above direction.

Wé deplore the condition of our state finances, and especially do we condemn the state treasurer for his failure to comply with the laws whereby the state has sustained an annual loss of not less than \$40,000.

We condemn the ring control of the district court of Lancaster county, whereby the state fund boodlers were sufficient evidence had been submitted to convict them, and after the supreme court had admitted the commission of the crimes. With feelings of humiliated pride, we condemn the action of the ederal courts in presuming to exercise jurisdiction over and interfering with the enforcement of a state law, as in the case of the maximum freight law.

We are glad for the success of mutual farm insurance in the state, and bid all the workers in this hi herto much

neglected field a hearty God spee !. We believe the solution of the liquor problem lies in the elimination of the element of profit, and therefore demand that the sale of liquor shall be exclusively carried on by the state at cost of Nuckols County, last Friday. Start-through salaried officials in such municipalities as shall apply for such agen cies, and that the national government shall regulate the importation, manufacture and transportation of all intoxicants so as to protect the states in their

exclusive management.

Resolved, That we view with alarm the action of the courts in enjoining the master workman of the Knights of Labor to restrain him from speaking concerning the labor troubles now existing between the Northern Pacific railroad and its employes. Free speech rights of the American citizen. The interference of the court with this most sacred right we regard as another evidence of the alarming influence which corporate power has over our courts. And we condemn in unmeasured terms the attempt in times of peace to suppress free speech as an act of high-handed tyranny, which should not for one moment be to erated nor submitted

Resolved, That we feel deeply humil-Resolved. That we feel deeply humiliated by having the leading industry of the nation so grossly misrepresented in the national department of agriculture by a man whose mind is too narrow to grasp the dignity of his position. And when Secretary Morton attempts to insuit the great body of preducers before and industrial cougress, he deserves our prefound pity for his ignorance, if it be ignerance, and our unmeasured it be ignerance, and our unmeasured condemnation if he knew better. In either case the administration, which will insist in retaining him in the high position to which he has been appointed, wilfully insults the industry which pays 80 per cent of the taxes, and creates the balance of trade in our favor with the nations of the world.

Second ballot for Treasurer resulted in the election of Jas. Cameron of Furnas county. First ballot for Lecturer resulted in the election of President Powers. Moved that the rules be suspended and the executive committee elected by acclamation. Carried. The following were elected as members of said committee: I. N. Leonard of Lancaster, C. M. Lemar of Saunders, E. E. Soderman of Phelps, L. W. Young of Furnas and J. M Dimmick of Franklin. J. M. Snyder of Sherman county was elected Chaplain by acclamation. J. N. Thompson of Furnas county was elected door keeper, A. E. Farris of Greeley county assistant door keeper, and W. O. Duncan of Kearney county as steward, in the same way. The N. F. A. & I. U. being entitled to a delegate to the National F. A. & I. U., proceeded to elect dele gate to that body. First ballot resulted in the election of W. F. Wright of Lancaster county. After leaving the meeting of the State Alliance, I put in an "Alliance Aid" degree in Clay County, of 11 members. Then went to Angus, Nuckols county. I have appointments for 5 meetings here. Will return to Clay county next week and Brother Logan McReynolds will act as county organizer of Clay county. Bro. Gro. F. Felion will be the county organizer for Nuckols county. Organization is moving surely forward and if all do their duty the Alliances of the State will be on their feet again soon in good shape for the future work before them. All that is necessary is to push the reorganization and the various co-operative agences started in the state. I had the pleasure of attending the meeting of the stock holders of the Augus Cooperative Store and Shipping Company ing two years ago, with a small capital of about \$2,000 stock. Their invoice last week of goods on hand was \$1,800, store building costing \$1,300, cash on hand \$600. They declared a dividend to all cash paid up of eight per cent. and a rebate of 16 cents on every dollar purchased by the stockholders. As an illustration, one man paid in only \$5.00 he got 8 per cent. interest, and bought at the store during the year enough so that his rebate of 16 cents on each dollar gave him \$22 00 in addition to the interest on his \$5. Brother Felton has \$245.00 paid up stock and the interest and rebate he received amounted to \$48. This shows what co-operation will do. Every county in Nebraska should have several such co-operative stores and shipping companies formed of Alliance men to do their own business, where not satisfactorily done by others. The work of two years done by this Alliance has been a splendid success and all desirous of information as to their system of work can get full information by addressing Bro. Geo.

Felton, Angus, Nuckols county, Neb. The county Mutual Fire Co. of the Farmers is growing rapidly here also. The "Alliance Aid" will seen be a permanent institution of this county, also. Co-operation along all lines is now the "Slogan cry" of Alliance men. Competition with all its silvery tones of deception and fraud must prepare to step down and out of existance as only the dying gasp of a barbaric age. Our Former Candidate for Governor Writes.

Union, Neb., Jan. 8, 1894.

Editor ALLIANCE-INDEPENDENT:-Having had the pleasure of your acquaintance at Hastings, I am constrained to write you toucning matters and principles showed forth in the Hastings, conference. After having passed a resolution of five minutes limit to each speaker, several persons, especially Green, were permitted to occupy at least from 30 to 60 minutes on matters impossible to arrange. When the silver question came to the Conference by report of a reliable and appointed committee it seemed to me to be the right and duty of our Conference to discuss and consider it fully. There are thous ands who will come to our aid when it shall be fully known that the Independent party is the only reliable silver party in existence, and that we are willing to make the opening of the mints the first business of congress.

If the Populist party is not straight on that question, then I am not for it. To lose silver as money will bring national banks to the front, and also down green-

backs and government issues. It is well known on all hands that gold coin never will do the business in this country, neither do the goldbugs desire that it should. But the money power expect to control gold and bonds, and by hese means control money circulation. What we want is to take a firm stand for 16 to 1, and elimenate from our national platform the sub-treasury, two per cent loan scheme, and subtitute the better plan, viz: issue legal tender paper money and pay the same out as other money into circulation, by the disbursements of the government for all purposes, the same as other coin money is paid for government indebtedness.

The above principles are fully sus-tained by the United States constitution, and can be maintained upon all occasions. It will be time to advocate a paternal government after first main-taining a just one.

We do not exactly sgree with Father Todd in his view of what constitutes a paternal government, or in his opposition to the government conducting the whole banking business, providing for loans as well as deposits. The mere government disbursement of silver and greenbacks within fixed limits will not put a stop to usury and wealth concentration. It would for a time check the rapidity of such concentration, but the relief would be but partial and very temporary. But as a party we favor the free and unlimited coinage of silver (the people want it) and we are the only party that does favor it. So any man who believes sliver should be remonetised belongs in our party.-Entron]
