The United States Senate voted down the United States entrance to the League Court last Tuesday, with a vote of 52 to 36, or seven less than the two thirds majority necessary to pass it. On this vote Senator Burke voted for entrance and Senator Norris against. Of the vote for entrance 42 were democrats and 9 republicans. In the vote against were 20 democrats, 14 republicans, one progressive, LaFollette, and one farmer-laborite, Shipstead. This was the first defeat the administration has had at the hands of the senate during its two years in office.
