RESOLUTION DECLARING THE RESULT OF THE SPECIAL ELECTION HELD NOVEMBER 12, 1935, ON THE QUESTION OF ISSUING \$61,000.00 COURT HOUSE BONDS.

Supervisor Carson offered the following resolution:
WHEREAS, There was duly and legally called a special election to be held on the 12th day of November, 1935, to vote upon the proposition of issuing \$61,000.00 Court House Bonds and taxes of Holt County, Nebraska, and
WHEREAS, said special election was in all respects held and conducted according to law on the day and date as was set out in the Notice of said Special Election, and
WHEREAS, The Canvassing Board, consisting of the County Clerk and two disinterested electors appointed by the County Clerk, did canvass the result of said election and examine the poll books and find that there was a total of 4554 votes cast on the proposition, 2,374 being cast for and 2,175 against the proposition.
THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY SUPERVISORS OF HOLT COUNTY, NEBRASKA:
