BANKER'S CLAIM IS REJECTED

State Auditor Howard Says Chadron Financier Has no Right to Collect for Unauthorized Trip to Pacific Coast.

(From a Staff Correspondent.)

LINCOLN, Feb. 17.—(Special.)—The Democrats and other friends of Dr. P. L. Hall of Lincoln, democratic national committee man, want him appointed to a position as director on the new federal reserve board created under the provisions of the new currency bill. They have written to N. J. Lodi, printing commissioner, saying if the president wants a good man that Dr. Hall is the man for the place. Dr. Hall formerly lived in Saunders county and the boost comes from his old neighbors, who say:

"Dr. Hall is without doubt the greatest financial asset the people of the west and the whole country have at his disposal, and while he is not a candidate and would not contest for the place, the president should make the appointment."

Howard Rejects Claim.

After waiting for some time for the attorney general to hand down an opinion whether Representative H. E. Reische of Chadron was entitled to draw expenses for going to California and bringing back John Bay, accused of defrauding the bank of which Reische is cashier out of some money, State Auditor Howard has tired of waiting and in a letter to Reische turns down his claim, informing him that the payment is refused because he was not authorized by the governor to go after the man or to act as an agent of the state.

The letter says:

"I believe that the governor has authority to approve only those bills incurred by agents appointed by him and inasmuch as you were appointed by him you were not an agent of the state and your claim would not properly come before him for approval or rejection and this office cannot legally approve a claim of a person not authorized to act as an agent of the state."

Suit Brought to Set Aside Deed to State Land in Madison

MADISON, Neb., Feb. 17.—(Special.)—Whitmore & Fisher company of Lincoln has commenced action in the district court against Frank A. Warner, Warnerville, and others to set aside a state deed, Feb. 10, 1914, conveying six tracts in section 18, township 23, range 1, west, Madison county. It is alleged in the petition that Warner fraudulently and fraudulently represented to the commissioner of public lands and buildings that he was the owner of the certificates of purchase of this land; that such certificates could not be found; that he was in actual possession of the lands, and that his right and title to said certificates and to said lands was not disputed or questioned by anyone, and relying upon his representations the officers of the state executed and delivered to him a deed. The petition further recites that the certificates of purchaser in question are the rightful and lawful property of the plaintiff since February 25, 1902, duly assigned to him by C. B. Burrows; that the deed from the state of Nebraska to Warner is void and should be cancelled.

This transaction seems to be more complicated by the fact that Warner has negotiated a loan on these premises from Maylard & Butterfield of Norfolk, Neb., for \$2,500, and secured same by first mortgage, which mortgage was recorded yesterday. It is stated that Maylard & Butterfield had advanced to Warner about \$1,500 of this loan. The officials of the office of the commissioner of public lands and buildings made an effort to recall the deed, but the register of deeds had already filed and recorded the same. It is not known just what steps the state of Nebraska will take in the matter.

LEVER BILL PROVIDES FOR FARM DEMONSTRATORS

(From a Staff Correspondent.)

LINCOLN, Feb. 17.—(Special.)—Several restrictions have been placed on the expenditures of money appropriated by the federal government for the carrying out of the provisions of the Lever bill. This measure provides for county demonstrations to aid farmers in securing better production and distribution of products. Any misapplied or misappropriated funds must be replaced by the state. No land can be purchased. Buildings cannot be erected, repaired or projected with the lever money. None of the money can be used for college courses. The rental of land is forbidden. Agricultural trains cannot be promoted. Not more than 5 per centum of each annual appropriation may be used for printing. Detailed reports must be made to the governor, the secretary of agriculture and the secretary of the treasury.

FUNERAL OF SENATOR BACON

Impressive Service Held in Senate Chamber at 1 P. M.

BISHOP HARDING OFFICIATES

Body is Taken to Atlanta, Where it Will Lie in State at Capital—Burial to Take Place at Macon.

WASHINGTON, Feb. 17.—Funeral services for Senator Bacon of Georgia were held today in the senate chamber. There were no speeches of eulogy, no music and no flowers except one design, the tribute of the senate itself, which rested on the coffin. The ceremonies were inspiring in their very simplicity and the place in which they were held with the dignity of those assembled to do honor to the dead, lent added impressiveness.

Two hours before the body was taken into the senate chamber it lay in the adjoining marble room. The public was excluded. Later the body was taken into the senate chamber and placed on the bier, directly in front of the vice president's desk.

Seats on the floor were reserved for the president of the United States, members of his cabinet, chief justices and associate justices of the supreme court, members of the diplomatic corps, members of the house of representatives, the admiral of the navy, the chief of staff of the army and the regents and secretary of the Smithsonian institution. Members of the dead senator's family and the officiating clergymen remained in the vice president's room until time for the services, when they were conducted to the seats reserved for them on the floor.

Admission by Card.

Admission to the galleries was by card, extended only to the members of the house and the more intimate friends of the dead statesman. One gallery was reserved for the use of those invited by the president and the vice president. Hundreds of those who came to pay homage to the dead statesman's memory were turned away.

When Vice President Marshall walked slowly to his seat and called the senate to order the short and simple services began. Departing from the customary form, Mr. Marshall, in a voice full of feeling and lowered almost to a whisper, said:

"Senators, the hour has arrived at which in accordance with the orders of the senate the final ceremonies over the body of Augustus Octavius Bacon, late a senator from Georgia and an unusually distinguished member of this body, are to be observed. In conformity to custom and in token of our common faith, the chaplain of the senate will offer a prayer to God the Father, God the Redeemer, and God the Comforter."

Rev. Forrest J. Prettyman, chaplain of the senate, offered prayer.

"We bless Thee for the life and work of this great man. We praise Thee that the hand of death was not laid on him until he had spoken his message to the world and had sent forth the influence of a devoted life into the soul of our nation," he said.

Bishop Harding Officiates.

The Episcopal burial service was pronounced by Bishop Alfred Harding of the Protestant Episcopal church, and a benediction followed by the chaplain.

Members of the capitol police force bore the body back to the marble room, where it remained until escorted to the railway station for the journey to Atlanta, where it will lie in state at the capitol until taken to Macon for interment.

The funeral party that accompanied the body south included the committees appointed by the two houses of congress and officials of congress.

President Unable to Attend.

It was announced at the White House almost at the last moment that President Wilson would not attend the funeral services. Dr. Grayson did not think it wise for the president to risk exposure at a time when he was recovering from a troublesome cold. Mrs. Wilson and Miss Helen Woodrose Jones, however, went to occupy seats in the reserved gallery.

Beside the casket in the marble room was a guard of honor composed of one veteran of the union army and one veteran of the confederate army. Senator Bacon of Georgia was J. B. Marshall of Birmingham, Ala., and the northern veteran was Major James A.

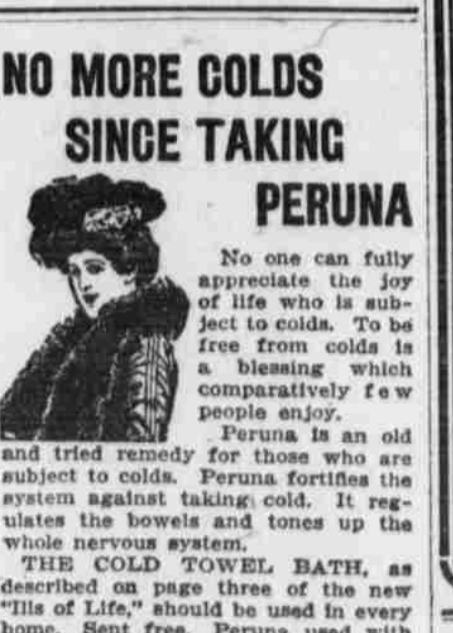
