GUNMEN CONVICTED OF MURDER BY JURY

Four Slayers of Herman Rosenthal, Gambler, to Pay Penalty in Electric Chair.

NO EMOTION SHOWN BY MEN Lefty Louie's Doll-Faced Wife Only One Who Weeps.

ATTORNEY SAYS WILL APPEAL Months May Elapse Before Ultimate Fate is Known.

JUDGE FAVORS PROSECUTION

NEW YORK, Nov. 19 .- "Gyp the Blood," "Dago Frank" and Whitey" Lewis killed Herman Rosenthal, the gambler, at the instigation of Charles Becker, and like him must pay the penalty of death in the electric chair. BALKAN ALLIES ARE READY TO NEGOTIATE TERMS OF ARMISTICE

Victorious States Accede to Request of Porte for Cessation of Hostilities.

PLENIPOTENTIARIES ARE NAMED Are Authorized to Arrange with

Generals for Truce. PEACE NEGOTIATIONS TO FOLLOW

General Belief that Victors Will Modify Their Demands.

NOTE IS SENT TO THE POWERS

They Are Thanked for Their Offer of Mediation and Notified Turkey Has Agreed to Trent Direct with the Allies.

BULLETIN.

SOFIA, Bulgaria, Nov. 19.—Bulgaria's conditions for agreeing to an armistice were transmitted to Constantinople early this morning. They were accompanied by Bulgaria's main conditions for the conclusion of peace, the principal stipulation of which permits Turkey to retain the city of Constantinople and a strip of coast territory in Europe.

BULLETIN.

LONDON, Nov. 19 .- An eight hours armistice has been agreed to between the Bulgarians and Turks at Tchatalja so that both armies may bury their dead, according to a news agency dispatch from Constantinople.

LONDON, Nov. 19 .- The nations of the Balkan confederation, satiated with victory, today signified their willingness to treat for terms of peace at the request,

of the vanquished Turkish empire. The luster of their success has been only slightly dimmed by their temporary failure to overcome the railled Turkish army at the gates of Constantinople and enter the Ottoman capital.

The stubborn defense encountered by the Bulgarians at the line of fortifications at Tchatalja and the realization that enormous slaughter would be necessary to pierce them at the point of the bayonet, with every prospect that their ranks would be decimated by cholera before they had attained success, doubtless proved the deciding factors in inducing the conquerors to listen to the urgings of the great powers and refrain from pressing home their victory.

Simultaneously with the dispatch to the grand vister of their agreement to appoint peace plenipotentiaries, the alited Balkan nations notified the European powers of the step they had taken and, thanked them for their offer of mediation. They added that mediation was no longer necessary, as the Porte had addressed itself directly to the Balkan

critical. Emperor Francis Joseph is reported to have remarked: We are in favor of peace, but not of peace at any price. We cannot stand

everything. The Austro-Hungarian cabinet has sent a sharp note to the Servian government at Belgrade demanding a precise reply to all the questions at issue. The Zeit says the note was distinctly threatening in tone and adds:

"Vigorous military measures will give emphasis to the diplomatic demand should Servia's answer again be unsatisfactory." Some papers assert that Servia is preparing to concentrate its main forces on the Austrian frontier.

Dipiomatic circles do not exclude the possibility that the Servians, relying on the sympathy of the slavs in Austria-Hungary and on the support of its Baikan allies, may challenge the issue.
