CHICAGO, July 24.-Continuance of negotiations by the federal board of mediation and conciliation in the attempt to ompose the wage differences between the engineers and firemen of ninety-eight western railroads and the railroad managers' committee hung in the balance to-

#### WAR CLOUD IS OVER EUROPE

Austria's Ultimatum to Servia Causes Apprehension.

ALL EYES ARE ON THE CZAR

Should He Back Up Servia General War in Eastern Europe is

Probable-Panle on Berlin Bourse.

BERLIN, July 24.-The grave possibilities connected with the strong Austrian note to Servia, which virtually took the form of an ultimatum demanding the suppression of the pan-Servian movement and the pun'shment of those concerned In the assassination of the late Archduke Francis Ferdinand, are recognized in official circles here. It is realized that further serious developments in Austro-Servian relations are inevitable unless Ser via complies with the Austrian demands It is believed in authoritative quarters that the Servians will yield unless assured of support from outside, and for this reason official eyes here are today turned less toward Belgrade than to St. Petersburg, where the council of ministers is expected to settle the question of peace or war.

Germany Approves Action. It was stated that Germany had not been consulted regarding the Austrian note to Servia before its delivery, but that it thoroughly approved the step taken and was prepared for all the consequences that might ensue from it.

It was pointed out that should Russia take part against Austria, Germany was fully prepared to draw the sword on behalf of its ally in accordance with the terms of the triple alliance of Germany. Austria and Italy. Comment in the German press today strongly supported Aus-

The stock market broke badly under the fear of general European complications. Securities in large amounts had been unloaded at the declines and the breaks in Austrian and Russian specialties assumed almost a panicky form.

Demand of Austria. VIENNA, July M.—An Austro-Hungarian note to Servia, containing demands for the suppression of the pan-Servian movement and the punishment of those concerned in the assassination of Archduke Francis Ferdinand, was presented to the government at Belgrade this evening. The note requests a reply by 6 o'clock Saturday evening.
