### Bluejackets Robbed of Excursion Fund by Former Bandman

ROME, Nov. 11.—The blue jackets of the American battleships Utah, Delaware, Vermont and Ohio discovered they had been robbed of \$12,000 which they entrusted to the care of a musician of the same name of Camerasso, a former bandman on the Utah. He was to have used the money for the purpose of arranging an excursion to Rome and an audience with the pope.

Camerasso was recommended to the sailors by Chaplain William H. Ireany of the Utah, who is now in Rome. About 1,000 blue jackets who wished to pay a visit to Rome handed over their money to Camerasso with instructions to engage a special train for them. This he promised to do, but when the men obtained shore leave and were ready to start they found that Camerasso had absconded with the cash.

A country wide search for the girl had been prosecuted under the stimulus of a \$1,000 reward offered by Mrs. Rhoda Russell Thomas of Springfield, the runaway's grandmother.

### Garrison Praises Defenses of Canal

WASHINGTON, Nov. 11.—Secretary Garrison returned to the Panama canal by his first trip to the Panama canal.

"The defenses constitute a marvelous feat in engineering," said Mr. Garrison. "The works are now in readiness for the installation of the fourteen-inch guns."

He explained that the guns are to be mounted at Atlantic and Pacific terminals and will have a range of ten or twelve miles, adequate to protect either Miraflores or Gatun locks.

### MURPHY IS AFTER MALONE Tammany Boss Objects to Nomination as Collector.

**WILL MAKE PROTEST TO WILSON**  
Selection of Senator O'Gorman's Son-in-Law for Best Post in New York Not Satisfactory to Organization.

NEW YORK, Nov. 11.—The rank and file of Tammany Hall heard today that Charles W. Murphy, state leader, was about to protest, President Wilson against the appointment of Dudley Field Malone as collector of the port of New York to succeed John Furroy Mitchell, mayor-elect.

According to the report, detectives have diligently gone over Mr. Malone's record as assistant corporation counsel of New York with a view to learning whether he was absent for many weeks during the presidential campaign and thereafter. These detectives also sought to scan the salary rolls. It was reported, to ascertain if Mr. Malone had drawn pay for the time he was absent, should such absence be proved. Their findings, according to current political gossip, were given Mr. Murphy. Last night, the story goes, Mr. Murphy consulted several others high in the councils of Tammany and decided to put forth every effort to prevent Mr. Malone's nomination.

An amplified account of the story published here today asserts that a trusted messenger, bearing Mr. Murphy's protest, left on the midnight train for Washington. Mr. Malone is the son-in-law of Senator O'Gorman, who is not at odds with the Tammany association. For some time past, however, Mr. Malone has aligned himself with the progressive element of the democratic party. In the recent majority campaign he spoke for the fusion candidate and against the fusion nominees, and thereby further incurred the ill-will of the organization.

Soon after his arrival Shepperd admitted his complicity in the shooting, according to the militia authorities, and told a story similar to the accounts related to the other five.

### Twenty Thousand Persons Employed in Ice Manufacture

WASHINGTON, Nov. 11.—(Special Telegram.)—Final statistics of the manufacture of ice in the United States for 1914 are given in detail in a bulletin soon to be issued by Director Harris of the bureau of the census, Department of Commerce. It was prepared under the direction of W. M. Stewart, chief statistician for manufactures.

This industry includes all establishments engaged primarily in the manufacture of ice for sale, together with a few cold storage houses making ice for sale in considerable quantities. For establishments such as breweries, cold storage houses and chemical factories which manufacture ice solely for their own use no statistics of any kind are included in this report.

In 1914 there were 2,094 establishments in the United States which were engaged in the manufacture of ice. The number of persons engaged in the industry was 21,167, of whom 16,114 were wage earners. The capital invested amounted to \$113,641,533, and the value of products was \$42,953,665. The total amount of ice manufactured was 12,647,399 tons, an increase of 18.7 per cent over 1913 and 73.7 per cent over 1904.

While artificial ice was manufactured in the United States as early as 1895, the industry did not attain any considerable importance until the decade ending with 1899. In 1900 establishments were reported from forty-one states and the District of Columbia. During the twenty years from 1880 to 1900 the value of products increased \$88,062,072, or 77.4 per cent, the value added by manufacture, \$7,676,373, or 98.3 per cent and the average number of wage earners 13,284, or 63.1 per cent.

### Sentenced for Crime Committed Fifteen Years Ago

SIDNEY, Ia., Nov. 11.—(Special Telegram.)—Judge Woodruff gave Thomas Silcott a sentence of two years at hard labor in the Fort Madison penitentiary yesterday for horse stealing. The case was without precedent in the local courts, the crime having been committed fifteen years ago.

In December, 1898, Silcott, a porter in a local hotel, hired a saddle horse of Lot Brown to ride to Hamburg, saying he would be back the following day. He failed to return and on January 16, 1899, the grand jury found an indictment against him for horse stealing. Lot Brown, the owner of the horse, has been constable for forty years and considers himself something of a thief catcher and he always said he would some day get Silcott, said Thursday he noted in the police notes in the Council Bluffs newspaper that a man named Thomas Silcott had been sent up ten days for drunkenness. Brown immediately went to Council Bluffs and brought back his man.

Silcott pleaded guilty and was taken to Fort Madison for two years. He said he traded the horse for a watch and a little money at Nebraska City, and has since wandered over the greater portion of the United States.
