REPUBLICANS CARRY BLUFFS

Dr. M. B. Snyder is Elected Mayor by Majority of 104.

Dr. M. B. Snyder, republican candidate for mayor of Council Bluffs, defeated Mayor Thomas Maloney in the city election Monday by a majority of 104. Dr. Snyder received 1,000 votes and Mayor Maloney 2,865. The republican victory came after one of the hardest fought elections held in the Bluffs in years and was the cause of great rejoicing among the members of the party who were welded together with common interest and fought a great battle.

With the republican mayor there is in all probability a republican council. For aldermen-at-large, G. J. Harding, republican, and W. A. Stone, republican, won sweeping victories. The democratic elected to the council J. W. Kelly in the First ward, B. Ganoude in the Fourth, W. C. Boyer in the Sixth.

In the Third ward, J. N. Minnick has a majority of four votes on the face of the returns, with about twenty-five disputed ballots yet to be disposed of in case of a contest. It is altogether probable that he is elected.

In the Second ward there was a close race between R. H. Williams, republican, and A. W. Huber, democrat, for the council. Huber, at a late hour, nosed out ahead by a small majority. The council will stand 4 to 4, with a republican mayor presiding.

Schneider Wins. Louis W. Schneider, democrat, won over Dr. E. Stuart, republican, for solicitor by a majority of 180. Frank True, republican, won for treasurer, over Chris Peterson, democrat. John F. McAnaney, republican was returned to the office of city auditor. E. E. Spelman, democrat, waged a hard and successful fight against C. B. Reynolds for city engineer and came out with a lead of 100.

Flock of Ducks Attacks Hennessey

Ed Hennessey, commercial agent of the Rock Island, returned Monday night from Schuyler, where he went to look after some contract freight business.

While out along the Platte river, south of Schuyler Mrs. Hennessey had several thrilling adventures and a corresponding number of narrow escapes from severe personal injury. As is always his custom when he goes out along the Platte on business, Mr. Hennessey took along a shotgun, and it was well that he did upon this occasion. As he was calmly and quietly pursuing his way along the river bank, flock after flock of ducks sought to attack him. Viciously and with malice aforethought the ducks flew at him in an effort to strike his eyes and blind him, and it was only by shooting at the psychological moments that he was enabled to drive the birds away. Before getting out of the snare that was apparently laid for him, he succeeded in killing twenty of the attacking ducks.

Mr. Hennessey says the flight of ducks along the Platte is the greatest he has ever seen and that they seem more ferocious this spring than ever before. They likewise seem bent upon waging war upon people passing along and carrying guns.

NEGRO WOMAN IS LYNCHED

Marie Scott Hanged to Telephone Pole at Muskogee.

IS TAKEN FROM JAIL BY A MOB

She Was Accused of Killing Lemuel Peace, a White Man, by Driving a Knife into His Heart.

MUSKOGEE, OKLA., March 31.—Marie Scott, a negro woman, who Sunday night killed Lemuel Peace, a young white man, by driving a knife into his heart, was taken out of the Wagoner county jail, early today and hanged to a telephone pole. The mob, which was masked, overpowered the jailer, a one-armed man, threw a rope over the woman's head and dragged her out of the jail.

A knock at the door aroused the sleeping jailer. A voice outside said an officer was there with prisoners. The jailer opened the door and faced twelve revolvers. He was bound quickly, his legs taken from him and he was thrown into a corner. The mob then pulled the screaming woman from her cell, tied a rope about her neck and dragged her to a telephone pole a block from the jail. An hour later the sheriff cut down the body.

Marie Scott, last Sunday morning stabbed Peace to death when he, with other young white men had gone to the negro quarter of Wagoner. The county attorney started an investigation of the lynching within an hour after it happened.

Wife Murderer Lynched. SANTA FE, N. M., March 31.—Adolfo Smith, charged with killing his wife Sunday by cutting her throat with a razor, was dragged from the county jail here early today by a mob of twenty masked men, his hands and throat slashed with sharp knives, his lungs punctured with stab wounds, and left lying in the street in front of the jail. He died at 11 o'clock, after doctors had spent three hours sawing up his wounds.

None of the mob has been identified. The city and county are being scoured for members of the mob.

Federal League Now Has Nine Umpires

CHICAGO, March 31.—Ed Goeckel was added to the Federal league staff of umpires today by President Gilmore, making nine arbitrators. Goeckel made a good reputation on local semi-professional diamonds last year.

R. B. Ward, president of the Brooklyn Federalists is expected in Chicago tomorrow to settle with President Weagham of the local club the disposal of Pitcher Tom Seaton. No difficulty is expected in arranging the dispute, according to Gilmore.

President Thomas of the Chicago Nationals, over the telephone today, learned from Charles P. Tate at Cincinnati that no bid for Cub stock had been received by the latter from Herbert S. Mills of Chicago.

BRITISH HOLIDAY RESORTS ORGANIZE A BOOM CAMPAIGN

LONDON, March 31.—A conference was held at the Guildhall, London, when the Federation of British Health and Holiday Resorts, of which the duke of Argyll is president, John Hinds, M. P., chairman, Captain Albert Larking, secretary of the Early Closing association, treasurer, and Ewan R. Davies, town clerk of Pwllheli, secretary, was successfully inaugurated. The objects of the federation are to popularize health and holiday resorts in the United Kingdom among British holiday makers and to draw a larger number of foreign visitors to the country. Efforts will also be made to extend the short holiday period. No less than sixty towns were represented and have already become affiliated, and an extensive scheme of advertising in America and on the continent will be undertaken. The government will also be urged to offer facilities for passing a measure empowering a rate to be levied for advertising purposes.
