## LAD KEEPS IDENTITY SECRET

Youth Baffles Efforts of Police to Find Out Who He Is.

HAS PENCHANT FOR THIEVERY

Although but Nine Years Old He is Full of Ideas Gained from Reading Cheap Literature of Dime Novel Order.

Officer Nielsen escorted from Hayden Bros' department store Saturday evening a 9-year-old embryo Jesse James, who succeeded in baffling the police to such an extent that they gave him up with heartiest thanks when Probation Officer Bernstein removed him from the matron's section of the jail.

The youth was apprehended by a floor walker, while pilfering several counters in the department store of their wares. But, on being ejected to the street, would return and repeat the performance. Officer Nielsen brought him to the station, where, folding his arms in a Washington-crossing-the-Delaware attitude, he steadfastly refused to answer Desk Sergeant Marshall's queries.

"I will give you my first name, which is David, but my last I won't tell you. I don't want the newspapers to get hold of this." Entreaties and threats availed the officers nothing, and the lad was finally removed to the matron's department to await Bernstein. While in the matron's apartments he turned the water spigots, flooding the floor, and upset a bookcase, breaking a flower vase.

"I refuse to give any facts; get me an attorney," were one of the few sentences vouchsafed by David. As Probation Officer Bernstein led him from the jail Saturday evening, he lurked back over his shoulder. "I'll make you suffer for this, I'll have my revenge."

The juvenile authorities were no more successful than the police except that they secured an inkling that David is suffering from an insatiable appetite for underdone literature.

## Special Case Comes Before Judge Foster Known as Duckicide

Judge Foster received his springtime proclamation Monday morning when the fowls of Mrs. Eliza Baker, 312 James street, were vilified and blasphemed by Mr. and Mrs. E. C. Tigue, 2700 Jaynes street, and a small army of witnesses testified to the heinous crimes of this flock of ambitious chickens. Mr. Tigue stated that Mrs. Baker "with malice aforethought," released her poultry every morning, with directions to them that they invade the Tigue premises and wreak havoc and devastation on the fragrant tulips and onions which were stretching forth to meet the warm April breezes.

Mrs. Baker said "It was all a darn lie, she never done no such a thing," and furthermore asserted that when one of her ducks did accidentally cross the dead line, Mrs. Tigue secured an iron bar and assaulted the poor thing, beating it something dreadful over the head and back.

Judge Foster, who was at this juncture on the point of bubbling over with joy and hilarity, succeeded in dropping his pen upon the floor before his feelings could gratify themselves with expression. "I fear I shall be forced to dimitia the case," he said, "as beating a duck with an iron bar comes under the head of duckicide, and Judge Cooley tries all such offenses."

An aftermath of unexpressible evidence was offered by the Tigue family to the effect that the Bakers had bombarded the house with missiles both hard and soft. But Judge Foster could not be moved from his decision.

## Onions and Singing, Like Oil and Water, Cannot Be Blended

## MISSOURI STOPS IN ITS RAVAGES ON THE FARMS

Word comes from the flooded districts along the Missouri, south of Omaha, that the waters are rapidly receding and that again the river is getting back within its banks and has practically stopped cutting. In the vicinity of Polson, the Burlington has been able to get control of the situation and the river has been turned into the old channel some distance from the east bank.

Down around Nebraska City and Peru, the river has fallen very rapidly since last Saturday and no more damage to farm lands or railroad property is anticipated. A number of farms on the low lands were practically all washed away, but the damage will not be nearly so great as was anticipated and reported early last week.

School children will plant trees and hold appropriate exercises and all grades will participate.

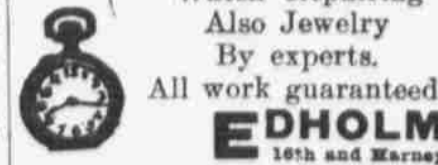
