MONTENEGRIN KING DECIDES TO YEILD TO POWERS' DEMAND

Nicholas Agrees to Give Up Scutari Fortress Torn from Turks May Get Compensation.

ATTITUDE OR RUSSIA REASON

Czar's Government Fails to Protest Against Attitude of Austria

No Date for Evacuation of City is Specified but Expectations Are Troops Will Begin Leaving at Once.

CETTINJE, Montenegro, May 5 .- King Nicholas of Montenesro decided today to evacuate the fortress of Scutari in response to the demand of the European

When he took possession of Scutari on April 23, after a six-months slege which cost the lives of thousands of Montenegrins and Turks, King Nicholas de-clared that he would hold the city until the last drop of Montenegrin blood had been spilt. As the European powers had decided previously that Scutari was to form part of the future autonomous state of Albania, a crisis was brought and the powers immediately brought strong pressure to bear to force him and his troops to evacuate the place. Some of the Montenegrin troops were said to resist a possible Australan ad-Then word came that Austria and Italy had entered into an agreement to solve the Albanian problem by a military expedition and it was known that the Austrian army was preparing to

The attitude of Russia under these circumstances was a matter of great concern to Europe and when it joined in the pressure being exercised on Montenegron great relief was felt, as it had been thought Russian would resist any attempt to order its army southward.

It was suggested during the negotia tions that the king of Montenegro would receive territorial compensation in another direction if he would give up Scutari and that his majesty was preparing to accept this offer.

Tension is Relieved. LONDON, May 5 .- Sir Edward Grey. the British foreign minister, announced at today's meeting of the ambassadors that Montenegro had unconditionally placed the question of the future of

College Men Will Be Trained for Army

WASHINGTON, May 5.-College men ider the latest scheme devised by the War department, will be organized into a reserve corps of officers available for the command of volunteer troops in case Secretary Garrison and Major General Leonard Wood, chief of staff, would establish two camps of instruction. one at Gettysburg and the other at the presidio at Monterey, Cal., to which the ollege students would be sent to be placed under the direct instructions of regular army officers who will be detailed to the two posts.

Major General Wood believes the plan will not meet with any objection from those opposed to so-called "militarism." nder the plan students volunteering for struction and drawn from the eastern and southern universities would be transported to Gettysburg, while those from other sections of the country would go to the Pacific coast. The plan has been carefully worked out and able-bodied students over 17 years of age will be given opportunity to learn the duties of an officer in command of men.

Letters already have been sent by the War department to the presidents of all the great institutions of learning of the suntry urging them to lay the matter before the students. It is believed that 2,000 college men will respond to the call.

Asked to Review Decision-JUSTICE SHEPPARD DISSENTS

WASHINGTON, May 5.-Contempt of ourt judgments against Samuel Compers. John Mitchell and Frank Morrison, the labor leaders, for their violation of a court's injunction in the noted Bucks Stove and Range case, were affiremd today by the district court of appeals, but the fall sentences imposed were held to have been too severe, so the court reducd Gompers' sentence from one year to thirty days and decreed that Mitchell

On the contrary it seems to me the natural conduct of a self-respecting man. Having sworn that he neither disobeyed or intended to disobey the mandate of the court a confession that he had done so would be a solomn admission of the commissin of wilful perjury."

Congressman Martin Dies Suddenly



BOMB FOUND AMONG PARCELS COLLECTED BY LONDON CARRIER

Package Contained Enough Nitroglycerin and Gunpowder to Destroy Postal Building.

SUFFRAGETTES ARE SUSPECTED

There is, However, No Direct Clue to Author of Ontrage.

MRS. PANKHURST IS THE DOSS Prosecutor Describes Militant Tac-

tics in Address to Court. WILD WOMEN OBEY HER OFDERS

He Says Receipts Found in Office Show that Members of Union Convicted of Crime Were Penstoned.

LONDON, May 5 .- A bomb containing sufficient nitroglycerin to demolish the great building was found among the packages collected by the parcels post at the southeastern district postuffice today. No clue was obtained, but the police attach suspicion to the militant satiragettes. The metallic sound made by the parcel aroused suspicion among the employes, several of whom were on duty at the time. The package was plunged into water and the police who were called opened it and found it filled with gun

powder, a quantity of slugs and a tube of nitroglycerine. Great interest was taken in the police court proceedings against the suffragette leaders, held on charges of conspiracy under the mallclous damage act, which were resumed at Bow Street today. Archibald Bodkin, the prosecuting counsel for the treasury, in opening the case, described the law of conspiracy and said the defendants had been constantly meeting together. He referred to "General" Mrs. Drummond as a "violent and unscrupulous woman." He said Clayton, the chemist, in whose possession were found documents describing a plan of campaign for burning down buildings in London, had put his brains at the disposal of the women for carrying out crimes and producing what their own paper described at "A reign of terror
