Appalling News to Hand From the Insur rection in the Phillipine Islands.

MADRID, September 25.-A dispatch to the Imperial from Hong Kong says steamers which have arrived there from Manilla, the capital of the Phil-lippine Islands, bring the announce-ment that Cavite is occupied by 15 000 insurgents. Over one hundred monks have been murdered on the island since the breaking out of the insurrection. Many victims have been fastened to trees, their clothing soaked with kero-sene oil and ignited, and the victims burned to death. Rich natives are being arrested daily. 
