#### HOW FELT HATS ARE MADE.

Photosonds of Men. Women and Boys Are Respinyed in the Industry.

One of the leading industries in this matry is the manufacture of hats. the present time for felt hats are In eleven states namely Conmetical, Indiana, Illinois, Maryland, dalke, Massachusetta, Missouri, New Jersey, New York, Prepayivania and theste island. There are in all more than 200 manufacturing plants produc ing hats for men's, boys', women's and children's wear composed of the fur of the rabbit, heaver, nutria, and other animals. The industry employee upward of 55,000 men, women and boys, and the approximate value of the out-put is said to be \$26,000,000 annually. Speaking of men's hats and their manufacture, a representative of one of the largest firms in this city said: "Felt hats include the popular derby and the various styles of soft hats, all of which are made from animal furs, the natural conts of the coney, hare, nutria, muskrat and heaver. To manipulate the for their toharco exports, and the policy skins of these animals so as to properly prepare the fur for felting purposes is an expert chemical operation, in fact, a trade in itself, entirely distinct from that of hatmaking, and is carried on by 'hatters'' fur cutters in London, the world's great center for that work. The art of the hatmaker includes a knowledge of the particular fur or combination of furs for making a given quality of hats. The proportioning of the different furs requires the utmost exactness. The quality of product having been decided upon, the fur is then cleaned and separated from stray hairs and all unfeitable substances. This in-Itial process is accomplished by a windy machine called 'the devil.' The next process, 'forming,' consists of distributing by means of air currents a light coating of fur upon the outer surface of a revolving perpendicular cone, perforated with small holes. When fur covers the cone sufficient for one hat It is wrapped in wet cloths and given a brief hot bath, then stripped from the cone, and, after the 'stopping' process of adding a little fur to weak spots, is wrapped with other cloths inside a woolen cloth to 'harden' it for handling. By a process called 'sizing,' which conints of repeated immersions in hot water, together with rolling and unrolling, folding and unfolding, the cone-shaped al size. It is wonderful how each fiber will twist and intertwine, basket fashton, with the other, until the product is a closely woven mass. The 'body' is then 'shaved,' to remove stray hairs in the fur, and then it is stiffened with a coating of shellac, thoroughly dried, and then subjected to steam, which softens the shellac and draws it into the fabric. When dried it is immersed in a hot alkaline solution to free the surface from shellac and then in cold water to remove the alkall. Blocking succeeds stiffening. The fabric is dipped in boiling water and placed on block patterned for the final shape of the hat. After the dyeing process comes that of finishing, which consists of steaming, blocking to shape the crown, drying, coating with a stiffening drying again, ironing out wrinkles, after which it is pounced with emery paper and singed to remove the long nap, and oil applied to smooth the surface. The 'curling' department cuts the brim to the desired width, rolls up the sides, and pitches the front and rear as the style demands. With the process of trimming, consisting of sewing on the binding and band and cementing the lining, the derby is fm-ished. If a soft hat is desired the stiffening process is omitted."-New York Commercial.

That this is the case all travelers agree, and it might reasonably he supposed two that as a result of what is a national habit, there would be an enermous consumption of tobacco in Spain, more specially in view of the fact that prove to the breaking out of the revolution the average tobacco erep of Cuba way 600.000 bales of more than 100 pounds each, and that Paerto Rico and the Philippine Islands have also expected large quantities of tobacco, there being sent from Manila in an ordinary year, when peaceable conditions prevall 100.000,000 cigars, exclusive of \$00,000,000 cigarettes and 2.500 tons of cut tobacco. Smoking being a general habit in Spain, the Spanish colonies (or former colonies) being notable of the Spanish government having been distinctly favorable to smoking. it might naturally seem as if Spain in this particular at least should take high rank among the countries of Europe Such, however, does not appear to be the case, for, leaving out Scandinavia. there is only one country in Europe that uses less tobacco in a year than Spain does, and that country is Italy. When the consumption per inhabitant is taken as a basis for comparison, the position of Spain is seen to be an insignificant one, for there is actually less tobacco used per inhabitant in Spain than in Scotland, where cigar smoking is rare and cigaret smoking almost unknown. The figures per inhabitant in ounces, taking the average of several years, are as follows in the countries named: Holiand, 55; Switzerland, 82; Turkey, 70; Belgium, 65; Gernamy, 80; Austria-Hungary, 42; Scandinavia, 40; France, 35; England, 33; Spain, 30. In all public places, social resorts, res-taurants, cafes, railroad stations, clubs, hotel corridors, and theater lobbles in Spain, the atmosphere is surcharged with tobacco smoke—so much so as to constitute a very objectionable feature in the view of American tourists. But notwithatanding this large supply of smoke, it would seem as if the con-sumption of tobacco did not keep pace with it. The explanation of the mat-ter is probably found in this, that Span-iards as a rule smoke cigarettes, in which tobacco is an important, but not exclusive ingredient, and that pipe-smoking is very little known in that in the consumption of tobacco, do not as a rule smoke cigars and seldom cig-arettes. They smoke pipes, and the consumption of tobacco in pipes would seem to be relatively larger than in cigars. Moreover, Spain is a dry counknown. 


