DEXVER, Colo., Feb. 5. - The truth in regard to the feal murder of Rev. Mr. Haddock at Siloux City, Ia., some years age loss been revealed at last, Mrs. Emma Drummond in open court adcused her husband as being one of the conspirators who, in the dead of night, slew the defenseless preacher.

The murder of Mr. Haddock is still fresh in the minds of everybody. He was an earnest Prohibitionist and very popular in Iowa. His entire influence was thrown into the scales against the liquor traffic. All America was startled one morning when they read that the hand of an assassin had struck him The must experienced sheaths in down. the country were put on the trail of the murderers and several arrest followed, including some prominent citizens of Sionx City. After a long and tedious trial the defendants were acquitted, and the prospect of ever dragging to the halter the slayers of Haddock was abandoned. But if the statements made by Mrs. Drummond are true the guilty parties will soon be brought to the bar of justice.

One of the largest crowds that ever assembled in a court room was present to listen to the divorce case of Emma Drummond vs. John Drummond. Mrs. Drummond is a blonde, tall, and of a graceful figure and carriage. Her whole demeanor while delivering her testimony was extremely haughty and disdainful. She testified that her husband was anxious to procure a divorce for the purpose of going to Yankton, S. D., to Marry a Muss Hattie Wren, who was formerly a mistress of his; that she had fallen heir to \$50,000, and she was willing to put up money for his living and gambling. Under the fire of cross-examination

the witness became greatly excited and created a sensation by stating that her husband procured \$2,000 from her mother to use as "hush money" to silence a notorious character called "Bull-dog Dick," who knew of the mur-der of Rev. Mr. Haddock in Sioux City, Ia., and that he also confessed to her that he was an all-round thief and had robbed a man on a Union Pacific train and was arrested at Omaha, and that afterward he told her in her mother's parlor of plans he had laid for the robbing of a Denver bank, but that she divulged the plot and prevented its execution. For doing this he beat her into insensibility and she was compelled to remain in bed for some weeks. The attorney for Mr. Drummond

dropped the witness and no further ques-tions were asked her. Few people real-ized the significance of her testimony at the moment, but the story of the mur-der of Rev. Mr. Haddock is on every lip.

WASHINGTON, Feb. 3.- In spite of the protest made by Congressman Houk and some of the other Tennessee Republicans against the consideration of the name of Judge Howell E. Perrin, of Kansas City, vice-president and Marion Taylor, of Louisville, secretary. The only active basi-ness of the day's session was the adop-tion of the report of the committee on resolutions strongly protesting against the whisky trust and the tax increase.




