At 11.20 evoluth President M. H. Goodell, of the Massachusetts Agricultural college at Amheret, headed a committee of four who called to talk to Mr. Cleveland with reference to the agricultural department of the government. The committee remained with the presdent-elect until I p. m. At the conclueion of the conference Chairman Goodell was asked as to the object of his visit, he said: "We as a non parti-san committee of four called upon Mr. Cleveland to urge upon him the impor-tance of having the department of agriculture so organized and administered as to meet the increasing domands of the intelligent farmers throughout the country for information based upon the latest researches of modern science

#### Jackson Named to Succeed Lamar.

WASHINGTON, Feb. 3. -Howell Jackson of Tennessee has been no # nated by the president to be associate justice of the supreme court of the United States, vice L. Q. C. Lamar deceased.

NASHVILLE, Tenn., Feb. 3.-Howell E. Jackson is a native of Paris, Tenn., and was born April 8, 1842. He gradnated from he Lebanon law school in 1858 and began the practice of law at Jackson. He was elected to the legislature as a State Credit man in 1860 and at the regular session of the legislature was elected to the state senate as a Dem-ocrat to succeed J. E. Bailey, who filled out the unexpired term of Andrew Jack-Jackson was a dark horse. He served in the senate until 1886, when Mr. Cleveland appointed him United States circuit judge for the Sixth district. He has been an able judge and his nomination as justic. of the supreme court is very acceptable, while at the same time it comes as a sarprise.

#### McLood Robs His Partner.

#### Worst in Five Years.

WEST SUPERIOR, Wis., Feb. 8.-The worst storm in five years struck the head of the lakes yesterday morning, following forty-eight hours of clear but cold weather, the thermometer going as low as 38 below zero. Snow has fallen all day with a northwest wind blowing from twenty to fifty miles an hour. Last night the thermometer had risen to 5 below zero, but the wind was increasing. The snow has drifted badly. Street car traffic was suspended at noon. One smoking car between two engines got through from Duluth at 4 o'clock, and then short line traffic was suspended. The evening Omaha train pulled out three hours late with three engines and little prospects of getting through.

### Wants of a University. \*

For Membership. Any white nale person born in the United States of North America.
