Gordon (Dem., Ga.) addressed the senate in favor of the unconditional repeal of the purchasing clauses of the Sherman act. In the concluding portion he advocated the repeal of the 10 per cent tax on state banks.

Teller Favors the Sherman Law.

Teller (rep., Colo.) addressed the senate in an argument to prove that the Sherman law is not responsible for the financial troubles of the country. Almost without exception, he said, every one who had addressed the senate had spoken as if there was some great calamity impending over the people of the United States. He wanted to enter his protest missed for incompetency and has been against "the calamity howlers of the unable to secure work. His mother and senate."

he believed that the people had brought about the panic because they were afraid of their money. If he did, he would be under some obligations to cite some instance where the American people had exhibited fright and fear of their money. EVERYONE HAS AN EQUAL CHANCE.

Initian Reservations Declared to He Part of the Strip. This Will Spoil a Scheme of tiuthrie Men to tlet the Choirest

ARRANBAR CITY, KRI., Aug. 80,- B. Barnes telegraphed to Secretary Smith asking if settlers would be allowed to make the run from the Chiloco, Osage and Pouca reservations. He received a telegram from S. C. Lamoreaux, land commissioner, which settles the question of points from which the run can finally be made

The president's proclamation states that the run shall be made from a strip of land 100 feet in width around and immediately within the outer boundaries of the entire tract of country to be opened to settlement. The Indian reservations of the Poncas and Otoes are all part of the Cherokee Strip and many people had made preparations to make the run from their boundaries. The south boundary of the Otoe reservation is only two miles from the county seat and land office, betweeen Perry and Wharton, and hundreds of Guthrie men intended to so to Perry on the train on the morning of the opening and, walking into the new county seat, claim the choicest town lots, arriving ahead of the horsemen from the Oklahoma line. In the same manner many intended to go from Arkansas City to the Kansas, Nez Peres and Ponca reservations and make the run to Bitter creek, Ponca creek and other important projected townsites.

The decision of the commissioner has been looked for on this point for some days and his telegram received effectually settles it as follows: "The president's proclamation reserves the Chiloeco, Osage and Ponca reservations from lands to be opened. I have no authority to grant parties permission to go thereon.'

An Army of Land Seekers.

WASHINGTON, Aug. 30.—The interior department has increased its estimate of the probable number of settlers who will engage in the rush on Sept. 16. Two weeks ago Land Commissioner Lameroaux estimated the number at 50,000. Now there is a general belief that it will reach 75,000. An amendmend has been made to the provisions of the president's proclamation as first published. It set aside every 18th section of a township for school purposes. The amendment provides that the 32d section of every township be set aside for a university fund, which will insure the new territory one of the best universities in the country.

More Troops For the Strip.

CHICAGO, Aug. 30,—Orders were re-ceived at General Miles' headquarters from Washington directing that a command be given four troops of the Third cavalry, now stationed at Fort Riley, Kan., to proceed at once to the assistance of the troops in Indian Territory.

THE LEADERS PAY THE PENALTY. The Two Leaders of the Seven Choctaws

Sentenced to Death Must Die. McALISTER, I. T., Aug. 80.-Sillan Lewis and Simon Wade, Choctaws, must die, so says Inspector Faison, on the part of the United States to Governor Jones of the Choctaw nation.

Monday of this week, in response to a telegram from Inspector Faison, Governor Jones, Judge Holson and District Attorney Lewis, met that gentleman at Caddo to determine what final arrangements, if any, could be amicably arrived at in reference to the condemned men at Wilburton. The position taken by the United States government was that the number sentenced was altogether too large, and that it would not subserve the interests of the Choctaw' people to execute all of them; that the leader or leaders should only be shot.

After a big parley and a review of the evidence in the case it was agreed that Sillan Lewis and Simon Wade, the pronounced leaders, should pay the death penalty on Sept. 8, and the other sentenced prisoners to be given a new hear-

Truxton Besie Assaults An Editor. SAN FRANCISCO, Aug. 80.—Truxton Beale, ex-United States minister to Persia, assaulted J. H. Cosgrove, publisher of a weekly paper, because of an article he printed, and was placed under arrest. Beale is a son of General Beale, now dead, who was one of the closest friends of General Grant. Under Harrison's administration Truxton Beale was appointed United States minister to the court of Persia. At that time he was 34 years old, and the youngest man ever appointed to a position of so much importance in the diplomatic service.

Sauger, had the body disinterred and strychnine was found in the stomach, His first and second wives also died suddenly, as did his brother, who lived with him in California. His first wife died in California about 1865.

Settlers Seeking Congressional Aid. San Francisco, Aug. 30. Several hundred settlers on about 200,000 acres of land in the San Joaquin valley affected adversely by a recent decision of the federal court, have sent a petition to congressmen asking such legislation as will materially aid settlers in getting speedy justice in the controversy between settlers and the Southern Pacific railway. They also ask indemnity from supreme court.

Allowed to Settle With Chief Arthur. TOLEDO, Aug. 30,-Judge Ricks has made an order allowing the receiver of the Ann Arbor railroad Company and Chief Arthur of the Brotherhood of Locomotive Engineers to settle the \$300,000 damage suit brought by the railroad against Arthur during the late trouble. Arthur agrees to pay \$2,500 and costs, also the costs in the case of the Ann Arbor and Pennsylvania, and other connecting lines that were brought into the affair.

Miners' Strike at an End.

LEAVENWORTH, Kan., Aug. 30 .- A general mass meeting of the striking coal miners was held. 
