The people of the entire state, regardless of party, extend sympathy to Lieut. Gov. Majors in the loss of his son.

Since Rosewater has taken his *Bea* and gone over to the populists he should hand in his resignation as member of the national republican committee.

The *Chicago Inter Ocean* was 21 years old last Saturday, and to celebrate the event issued a 60 page paper. The moral tone of the paper has always been of the highest order and it is a credit to the world's fair city.

It is rumored that Rosewater's mind is becoming unbalanced. It is to be hoped that the rumor will be proven false. The loss of his reason is a greater calamity than his worst enemy would want to see befall the brilliant editor, notwithstanding the unprincipled methods he resorts to.

The Newberry bill has been recommended to pass by the senate and will likely become a law. Then this part of the state will likely have poorer train service than it now has and through rates be raised and the development of the country will be retarded simply to satisfy a few extremists.

The populist leaders in the south now declare that that party is entirely superfluous in that part of the country, at least. It was used as an assistant to the democratic party. That party is now in the saddle and the pops are not in it. Even the men who attempted to ride both democratic and populist horses have no standing, as is evidenced by the failure of Billy Bryan to control the patronage when Morton shows his hand.

On March 24th Col. E. D. Webster, of Stratton, died at Washington, D. C. He was one of the pioneer newspaper men of Nebraska and was well known throughout the state. He was a member of the republican national convention at Minneapolis. In 1890 Col. Webster was the first delegate to a national republican convention ever named in Nebraska and he has always done active work for the party in the state.

There is an army of men employed upon the railroads of the United States, an army of 784,000. They are not engaged in idle maneuvers, dress parades, barrack drills, or preparations for warfare, but by their diligence, energy and toil contribute immensely to the wealth, well being and development of the country, the interchange of its products, the diffusion of information, and the prompt transportation of vast numbers of passengers, with a remarkably low percentage of casualties. The number of passengers carried last year was 530,000,000. The number of passengers killed was 263.—*Scientific American.*

An investigation of the board of public lands and buildings would be all right and proper, but to bring impeachment suits against them to satisfy the ghouls who edit the Omaha *See* would be a great injustice to the members of the board. An investigation which would find all the facts should be made. Then if the evidence would warrant it impeachment proceedings could be instituted. An official does not have to defend himself in an investigation, but in case of impeachment he does. Rosewater never loses an opportunity to blacken the record and reputation of a public official who does not crumble to his whims and men of intelligence should ignore his unreasonable demands.

In the matter of a state fair exhibit there is a most excellent opportunity for co-operation by the four northwest counties of Nebraska. By taking the matter in hand now the details could be arranged so as to have the county collective exhibits of Box Butte, Dawes, Sioux and Sheridan counties all located close together in the agricultural hall and much more effective work could be done by those in charge than would be possible without an arrangement of that kind. If the officers of the agricultural societies of the counties named take this matter up there is no doubt of its being carried out successfully.

The March report of the secretary of agriculture, the first one to which is attached the name of J. Sterling Morton, relating to the wheat on hand and the quality of that grown in the different states, contains a good deal of interesting information. The amount of wheat on hand March 1, 1893, was 135,000,000 bushels, 36,000,000 bushels less than was on hand a year prior to that date. Another fact is that the wheat of North Dakota weighed on an average 55.5 per bushel and that of South Dakota 55.2 per bushel, while the wheat of Nebraska averaged 58 pounds per bushel. Nebraska has in the past, claimed much recognition as a wheat growing state but the time is at hand when she is bound to take her place as one of the leading states in the production of that cereal.

It would be an excellent thing if some one would devise a method whereby true reports of the matters transpiring at the legislature could be given to the public. A few days ago the senate in committee of the whole had the Newberry bill under consideration. A motion was made and carried that the committee rise. When the committee of the whole rises the rules of the senate and parliamentary practice provide that the roll shall be called and that the presiding officer may know and announce that the senate is legally organized and ready for business. While the roll call was being made at the time mentioned Senator Dale, a populist who seems to possess more lung power than knowledge of the rules governing the body of which he is a member, demanded a call of the house. Lieut. Gov. Majors coolly but firmly ordered the roll call to proceed and then other pop members, including the statesman from this district, got excited and some even grasped inkindness to hurl at the head of the presiding officer. When the roll call was completed the ranting noise was recognized and the call of the house was made. That gave Rosewater a chance to roast his old enemy, Majors, and the *See* of the next morning contained a long article telling how Majors had attempted to defeat the wishes of the people in the interests of the corporations and every populist agitator all over the state took up the cry and enlarged upon it and added to it until any one who did not know the rules followed by the senate was lead to believe that the lieutenant governor had committed an act of treason and should be hung without ceremony, instead of which he was simply performing his duty, which he understood better than the populist senators did theirs and better than Rosewater was willing to admit.

The scene here at night is indescribably weird. Seated upon an overhanging cliff one can watch the surging waves of fire seething to the mouths of the yawning chasms whose depths are in the hollows of the earth's fiery heart. Horrible spouts of white fire belch forth from the caves, dashing the flaming spray wide and high. Huge cakes of dark crust tilt and plunge and are sucked down into the seething vortices. The forked tongues of flame dart up like fiery demons from the yawning abysses, and one can revel in a plethora of imaginary horrors which seem to fittingly belong to that region.
