In county convention a few days ago the people of Box Butte county had a national bank official as chairman and as a result no resolutions were passed condemning the financial institutions chartered by the government.

The constitutional convention of South Carolina a few days ago decided that there shall never be a divorce granted in that state for any cause whatever, neither shall divorces that have been obtained in other states be recognized there. That makes a pretty strong demand for national legislation on the subject of divorce.

In New York the republicans and the state democracy have united, or rather fused, for the purpose of defeating tammany. They will be assisted in the effort by the good government clubs of the city. From all over the country reports show that fealty to party does not demand the answering to the crack of the party lash in local matters. In fact the party laws are more lax now than at any time in the past and it is likely to become even more so.

The Bank of Hemingford was closed a few days ago by the state banking board. It is claimed by the cashier that depositors will be paid in full. A general store which was being backed by the bank was also closed. The indications are that the county seat of Box Butte county is almost certain to be moved back to Alliance about the first of the year, and as much of the land about Hemingford has been deserted, it will not be long until there will be little more of the place than a postoffice. Towns cannot grow, or even hold their own, when the settlers are deserting the country.

The republican state convention at Lincoln on last Wednesday was a most harmonious and enthusiastic gathering. Chief Justice Norval was named as the choice of his party to succeed himself by acclamation, unanimously—a fitting acknowledgement of the honorable service rendered by him during the past six years. C. H. Morrill was nominated for a second term as regent and H. L. Gould was named for the other regency. A grand parade and ratification meeting followed the convention. The reelection of Judge Norval is conceded by all who are familiar with the political conditions which prevail throughout the state, and the nominees for regents will also be elected by good majorities.

A change has been made in the state fish commission and it is reported that an attempt will be made to depose M. E. O'Brien as superintendent of the state fish hatcheries. If the change is made it will be for purely political reasons. Mr. O'Brien spent years in acquiring the knowledge necessary to fit him for the position he holds. Now that he has incurred the displeasure of the political powers that be he is to be fired and some one put in there who does not know what is necessary to bring about the best results, and the tax payers of the state will have to pay for it. The fish industry is an important one in this state and its importance is increasing every day. It does not seem right that the interests of the people should be sacrificed to allow some politician to
