The bill proposing to repeal the law defining what shall constitute a legal newspaper was defeated in the House last week. An attempt was made to so amend the law that a paper might fail of publication a few weeks during the year and still be a legal paper, but the lawmakers evidently believe that a paper should be published once each week for at least fifty-two consecutive weeks before it should be considered established well enough to be a legal paper.

Judge Westover when asked for his opinion as to whether or not the populist should abandon free silver, expressed himself very fully and vigorously. He said he was unalterably opposed to such a conclusion and believed

ed after mature deliberation the party as a whole would decide that the money question was the principal issue before the American people and that the abandonment of the silver issue at this time would be a fatal mistake.—*World-Herald*.
