### Vesuvius Long in Action.

The most recent excavations show that Vesuvius began its work as a conservator of antiquity earlier than the memorable year A. D. 79. During the excavations in the valley of the Sarno, near San Marzano, some most interesting antiquities have come to light. These had been covered up by a volcanic deposit about six feet thick which points to an eruption of Vesuvius which must have taken place in the seventh century before Christ. The relics include a Greek burying place, archaic Italian tombs and various bronzes and terra cotta.

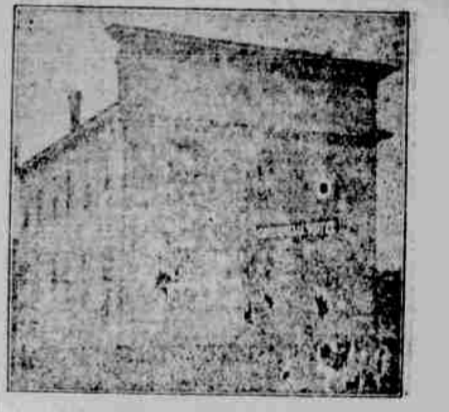

### Washing Cut Glass.

Cut glass or any crystal should be washed in warm soapsuds, rinsed in warm water, then covered with clean, coarse sawdust for ten minutes, after which it should be lightly brushed with a clean soft camel's-hair brush. Avoid extremes of temperature in handling glass, and under no circumstances allow cut glass to be put in the refrigerator.

### Former British Soldiers.

At the close of the Boer war 24,000 British soldiers sought employment as coachmen, porters, carmen, etc., and places were promptly found in England for 18,000. Later the number of unemployed former soldiers has increased, owing to the present service of three years with the colors instead of seven years as heretofore.
