FARM BUREAU NOTES

STOCK JUDGING CONTEST

Webster county boys take part in Stock Judging Contest at Hastings. Ninety-seven contestants from seven counties compete.

The contest started at H. Gaudreault's Hereford farm where two classes of Herefords were judged. Then two classes of Durock hogs at Jack Dunn's farm, Jersey cattle at C. E. Yost's Dairy farm, Guernsey cows and Hampshire sheep at E. J. Newkirk's farm, Shorthorn cattle at Biglin and Loman's farms. This was followed by a big noon-day picnic at Prospect Park where we were the guests of the Adams County Live Stock Clubs, Hastings Chamber of Commerce, Lions Club and Rotary Club. After the splendid dinner we were welcomed to the city by Mr. Cottingham of the Chamber of Commerce, also by Volney D. Trimble of Lion's Club and Tony Lmbach of Rotary Club. After the contest the Club folks were given an automobile tour of the city and theatre guests of the Chamber of Commerce.

Webster county boys won Trophy cup and nine ribbons as follows: Cecil Means of Red Cloud ranked first judging Holstein and fourth on horses. Earl Portnier of Guide Rock won fifth on horses. William Arndt of Blue Hill won fourth on Holsteins and second on horses, fifth on Guernseys and sixth on individual score. Alfred Sommerfelt of Blue Hill first on cattle and silver loving cup presented by H. C. Gaudreault and Son of Hastings for the high score in judging Hereford cattle. Paul Gurney and Oscar Ramey the other two Webster county boys only placed the three classes of Dairy cattle.

The club members were numbered and were known in the contest by number instead of name. One of the Webster county boys forgot to put his number on the horse card. If he hadn't over-looked this he would have ranked second high individual and the Webster county team would have ranked second instead of fourth.

Adams county won first. This was a good contest and highly appreciated by the visitors.
