BERLIN, Dec. 2.—(By Wireless to Sayille.)-The Overseas News Agency says. "The German government has published hotographic reproductions of documents having to do with the execution of Julia Van Warterghen in Antwerp on August 2, 1914, by Belgian soldiers. "This woman was convicted by a Bel-

gian court-martial, whose findings were approved by the Belgian war minister. The documents, now in the possession of the German government, and the fact Entente Powers that the French have sourt-martialed and shot women spies during the war, show how much weight should be attached to the expressions of indignation in England and France at the execution of the English nurse, Miss Cavelt."

Deformed Baby that Caused Discussion at New York Dead

NEW YORK, Dec. 2.-Margaret Rob erts, the deformed and paralyzed baby whose birth caused a discussion here similar to that over the defective baby allowed to die recently in Chicago, died today in a hospital.

The infant was born November 23. Its lower limbs were paralyzed and its feet deformed, but its mental conditions was thought to be normal. Dr. Maurice Rosenberg, the physician who attended Mrs. Roberts, asserted that a simple operation could save the child's life and mentality although it would be a life-long cripple. He offered to perform the operation but after considerable controversy it was decided to leave the child's fate to a board of physicians. This board decided against the operation.

Jury is Secured to Try Alleged Robber of Stage Coaches

CHEYENNE, Wyo., Dec. 2 -A jury was scured today in the United States district court to try Edward F. Trafton, charged with the stage coach holdup in Yellowstone National park July 29, 1914. and the prosecution began its opening

In his preliminary statement United States Attorney Charles L. Rigdon described how an outlaw, alleged to be Trafton, had stopped twenty-three stages in the park as they came around a point of rock, holding the drivers and passen gers at the point of a gun until he had more than 100 persons collected, and how he had compelled the persons to march past a blanket and throw their money and valuables thereon, and afterward escaped. He outlined the alleged movements of Trafton from early in July until he appeared at Griggs, Idaho, on July 31, two days after the robbery, where the proseutor alleged he procured a complete new outfit, displaying more money than he was known to possess prior to the robbery. Rigdon charged Trafton with having stolen two horses from a camping party near Jackson lake, south of the park, on July 20, and with having held up and robbed a sheep herder of provisions and two saddles July 25. These stolen horses, it was charged, subsequently were identified as the animals used by the park robber,

BERLIN, Dec. 2 .- (Via London.) -Teutonic forces, pressing their campaign against Montenegro, have occupied the towns of Plevije and Jabuka, in northeastern Montenegro, near the Serbian border. German army headquarters announced today.

LONDON, Dec. 2 .- Military events in the Balkans are apparently in a transitory stage, which may preface another German offensive, but whether this will be made against the Franco-British troops, which hold all that remains of Serbia, or against the Russians, should they from the east, the present situation gives no indication.

A Saloniki dispatch reporting withdrawal of Field Marshal Von Mackensen's forces from the Serbian front to Bulgaria is interpreted in some quarters as confirmation of the second alternative.
