### WILL OF GEN. DODGE FILED IN PROBATE

Majority Left to Heirs, but Sum is Set Apart for Bailroad Men's Library.

#### HELP FOR INDIGENT VETERANS

The will of General Grenville M Dodge was filed in probate court at Council Bluffs late yesterday afternoon. No inventory accompanied the filing, but the bequests are based upon an estimated valuation above \$600,000. N. P. Dodge, Jr., of Omaha, son of General Dodge's brother, N. P. Dodge, is made chief executor. Mr. odge and Frank S. Pusey, sonin-law of General Dodge, residing in New York, are given custody of practically the whole estate to hold it as trustees and distribute the pro-

Every interesst of very member of the family is carefully quarded, and there are large bequests outside of the family. The city of Council Bluffs is made the trustee to hold the sum of \$100,000 to be administered in accordance with the terms of the will. Of this sum \$50,000 is to be used for the establishment of a public library and reading rooms for railroad employes, and \$60,000 is to be invested and held in trust by the city, and the income is to be used for the benefit of indigent soldiers of the civil war and their families residing in Council Bluffs. When the time comes that none of the old soldiers' dependents remain then the income is to be given to some hospital or organization for the care of the needy, sick and injured persons.

The amount of these bequests are based upon the assumption that the estate will exceed \$600,000. The homestead on Third street in Coun-

ell Bluffs is left to Mrs. Dodge and her three daughters as long as they shall live. The rest of the estate is put into a trust fund out of which \$2,000 annually is to be paid to Mrs. Julia D. Beard, sister of the general. One-third of the remaining income is to be paid annually to Mrs. Dodge and the remaining twothirds equally divided yearly among the three daughters or their other heirs.

The trust fund is to remain in force according to the will until twenty-one years after the death of the youngest grandchild of General Dodge when it is to be divided as follows:

One-half is to be divided among the heirs, one-fourth is to go to the city of Council Bluffs to be used for the relief of civil war soldiers and one-fourth goes to Norwich university, Norwich, Vt. The entire library of General Dodge,

probably the largest in Iowa, goes to the Council Bluffs public library and his records of historical value to the Iowa Historical association In addition to his other bequests, Mrs.

Dodge is to receive the income from the Frank S. Pusey trust fund, established in 1894, the value or purpose of which is not stated in the will.







#### ENGLAND MAKES **NEW MAN CHIEF** IN MESOPOTAMIA

(Continued from Page One.)

Turks have advanced to the main defenses of the British. The main British army in Mesopotamia ocording to these advices, is in retreat,

10,000 men having been left in Kut-el-Amera, to protect the position Recent dispatches have indicated that the British expedition in Mesopotamia was confronted by superior Turkish forces. The British repulsed several assaults on Kut-El-Amara.

The retreat from Kut-El-Amara-acsuming the correctness of the official advices from Berlin-apparently means the abandenment by the British of any attempt, for the present, at least, of an offensive campaign in Mesopotamia.

It was in November, 1914, that an Anglo-Indian force; starting from the Persian gulf, began marching north and the desert, following the Tigris and Euphrates rivers wherever possible. The fighting was slow, but the British pushed northward steadily until they reached Ctesiphon, eighteen miles below Bagdad. Here the Turks defeated Amara, 106 miles southeast of Bagdad.

### HIGH COURT ACTS IN MEDICINE CASE

Decision Reached After Ten Years of Legislation and Litigation.

OMAHA END TO THE MATTER

WASHINGTON, Jan. 10 .- After ten years of legislation and litigation, the supreme court decided today that congress had enacted finally a constitutional law regulating statements as to the curative effects of medicines in interstate commerce. The decision was rendered by Justice Hughes. Numerous actions against drug concerns are expected to fol-

For a time is was urged by government officials that the 1906 pure food law designated as misbranded drugs or medipowder early today at the plant of cines, which were accompanied in interstate commerce by knowingly false statements about the curative effects of the compounds. The supreme court decided. however, that the 1906 law applied only to misbranding as to the identity or composition of drugs.

Acted at Taft's Suggestion.

In response to a resulting message from President Taft, congress, in 1912, enknown, but according to the superin- acted the Sherley amendment which the tendent there is no suspicion that the supreme court held today struck precisely at misstatements either on the label or in printed circulars accompanying the medicines.

'We find no ground," said Justice Hughes, "for saying that congress may not condemn interstate transportation of swindling preparations accompanied by false and fraudulent statements as well as lottery tickets."

The justice held that congress had not ntered the field of difference of opinions between schools and practitioners, but had merely sought to exclude "false and fraudulent" statements from interstate commerce. He held the law was not speculative in its nature, because an intent to deceive was a fact as susceptible as other facts in every day life.

Shipped to Omaha.

The decision was announced in the case of a Chicago drug concern which shipped medicine from Chicago to Omaha, described in an accompanying circular as a compound which it knew had cured and would cure tuberculosis.

The government proceeded under the Sherley amendment to confiscate the product and the Nebraska federal district court condemned the shipments. This action was affirmed today by the supreme court.
