## TO PROBE LAW VIOLATIONS

Ministerial Union Appoints Committee to Interview City Dads.

## WILL MAKE WRITTEN REPORT

Rev. Titus Lowe of First Methodist Church Starts Move, Declaring Something Ought to Be Done.

A committee of preachers has been appointed by the Omaha Ministerial union to investigate alleged violations of law in Omaha, interview the city commissioners and make a written report to the union at its next meeting.

Declaring that he had heard of a number of cases of lax enforcement of law, if not outright neglect in enforcement, Rev. Titus Lowe of the First Methodist church started the ministers on the road to a probe by declaring at the Monday morning meeting that "something ought to be done."

A committee of preachers, "backed up by a delegation of strong laymen," was thereupon proposed by Rev. Thomas Evans, pastor of the United Evangelical church. He moved that the committee be appointed to call on Commissioner A. C. Kugel, superintendent of police, in regard to law enforcement.

"Oh, Kugel means all right," declared Rev. F. A. High, local superintendent of the Anti-Slavery league. "He is not as strong for strict law enforcement as he is used to be, but he complains that he is not getting proper support from the good people of the city."

"Let's go after the whole city commission, instead of just Kugel," Rev. F. Ramsey suggested.

"If things are as they seem," he declared, "a body of ministers like this ought not to sit still without a vigorous protest."

As finally amended and carried the motion for a probe of the question of law violations and enforcement directed that a committee of five pastors "investigate the facts and make a written report."

Rev. A. C. Douglas, pastor of the First United Presbyterian church and president of the union, appointed these pastors on the probing committee: Rev. Titus Lowe of the First Methodist, Rev. E. H. Jenks of the First Presbyterian, Rev. Arthur J. Morris of the Immanuel Baptist, Rev. J. H. Board of the Central Park Congregational, and Rev. Thomas Evans of the United Evangelical church.


