

HAVOC OF HARRIMAN STRIKE IN NUMBERS

Attorney for Men Says Sixteen Driven to Suicide and Nine Made Insane as Result.

PUBLIC OPINION INFLUENCED

CHICAGO, April 11.—The havoc wrought among the 30,000 shoppers, whose strike against the so-called Harriman lines in 1911 was lost, was sketched statistically yesterday before the United States commission on Industrial Relations.

The witness was Frank Comerford, for many years attorney for the men. One thousand question blanks were sent at random to the strikers thirty-four months after the strike. His figures, Mr. Comerford explained, applied to these 1,000 men, and he thought that a fair social survey of the whole number could be obtained by multiplying his figures by thirty.

Effects of Strike. Of the 1,000 men whose replies were checked up, according to Mr. Comerford, 18 were single when the strike was called, September 30, 1911. There were 1,718 children, a small number which he thought might be traced to low wages and a sub-normal scale of living.

Mr. Comerford stated that of 115 cases of strikers defamed by himself, 115 resulted in acquittals, "not through any cleverness of mine, but on the merits of the cases. The arrests appealed, more to the news instinct of the editors than the demands, however, and the fact that 118 of the men were innocent received far less publicity than the facts of their arrests. I do not attempt to criticize the newspaper in this connection—it just happened that way," the witness continued.

COUNTY FAIR WILL INSTALL NEW PLAN

Modern Grounds to Be Provided on Tract Between Omaha and Benson Near Krug Park.

RACE TRACK, NEW BUILDINGS

Where shall the county fair be located? This question, long a source of strife in the Douglas County Agricultural society and the cause of a near riot at the annual election last October, has at last been settled, and quite permanently, the officers think.

The directors at yesterday's meeting decided to settle the issue for at least five years by a compromise that was acceptable to practically all of them. Under the arrangement agreed upon, Benson business men will pay the \$200 annual rent on the proposed grounds, fence them and furnish light and water.

Improvements to Be Made

The property belongs to the Metropolitan Water district. The grounds will be improved with a race track, grandstand and suitable buildings for housing the fair, the agricultural society to meet that expense. "We are all glad the fair location is settled," said Treasurer Louis Henderson after the meeting. "It means that for at least five years the county fair will be held across the road from Krug park, convenient to both Benson and Omaha by street car and auto, and also to the west, north and south ends of the county by main roads. The location is the most practical available, for it is near the center of population, will get big crowds, and will be a fine improvement to Omaha as well."
