WASHINGTON, Sept. 19.—The Interstate Commerce commission today decided to reopen the advance rate case and will begin hearings here on October 19. A formal order to that effect was prepared. Western railroads already are preparing applications for increases in freight rates so that when the commission begins the rehearing it will have substantially before it applications for increased freight rates from the Atlantic to the Pacific.

Japanese Order for Air Motors Refused

BERLIN, Sept. 18.—(Via Wireless by Way of Saville, L. I.)—According to the Cologne Gazette, Japan sent a special commissioner to a German motor company during the first days of July to order 600 aeroplanes motors to be delivered within the shortest limit of time. The order, however, was not carried out. The German governor of Belgium (General von Goltz) has appointed Privy Councillor Dr. von Falcke to decide on ways and means to protect Belgian treasures of art against burglars and pillage. Dr. von Falcke is now making a tour of Louvain, Namur, Huy, Nivelles and Liege accompanied by a Belgian art expert named Ortel, and will take whatever measures to this end may be necessary. It is announced that three aeroplanes are again over Paris. The British naval commission has left Constantinople. The Russian general (Paron), who ordered the shooting of eleven of the male inhabitants and the burning of all villages in east Prussia, has been tried by a German court-martial.

BRITISH ORGANIZE MORE MILITARY HOSPITALS

LONDON, Sept. 18.—Through the efforts of the war office 150 military hospitals have been organized in Great Britain. These have been arranged in groups and each has an administrative center. Practically all the sick and wounded returning from the continent are received at Southampton, and from there those whose condition is the most serious are sent to Royal Victoria hospital, Netley, and the others are distributed where their cases can be handled to the best advantage. Rheumatism, brought on by exposure, makes the condition of some of the injured very pitiful. Some typhoid has been reported among British soldiers in the field. Sir William Osler's suggestion that the American plan of inoculating all soldiers against typhoid be adopted is generally supported by the press.

French Recall Pau's Interesting Reply. PARIS, Sept. 18.—The French papers are recalling an interesting reply which General Pau made a year ago when his admirers proposed to present him with a sword of honor upon the occasion of his giving up command of the Twentieth army corps. "I certainly should not accept the sword of honor that you and other well meaning patriots think of giving me," he said. "Such a recompense must be reserved for the man who shall lead our victorious armies beyond Metz and Strassburg, beyond the Rhine, into the very heart of the German empire. As for me, modest worker in times of peace, enemy to publicity and popularity, it is sufficient that I have the confidence of those who have served under my orders, and the suffrages of good people such as you." URE SUGGESTS CITY BUY PROPERTY AT TAX SALE. Twenty-four acres of low ground in the city of Omaha, lying northwest from the German Home on South Thirteenth street, has delinquent taxes and interest assessed against it that total more than \$200,000, the actual value of the property being \$25,000. He suggests that the city buy the land at tax sales and hold it for a public playground, when that part of Omaha becomes more densely populated. The property is known as tax lot No. 31, and runs from the German Home to Cottage park addition. The ownership is undetermined, as title is involved. Since 1902, no taxes on it have been paid, and the amount with the accrued interest is about \$200,000, or over \$500 per acre. Treasurer Ure says the land is worth not over \$2,000.
