AFFAIRS AT SOUTH OMAHA

Police Board Members Resume Activity Over Murder Case.

GET BUSY AFTER THE CRIME Expect to Have Floaters and Pool Hall Hangers-On Taken in Charge Until They Can Explain Their Goings and Comings.

Feverish activity was noted among the members of the South Omaha Fire and Police board after an informal meeting last night when the murder of 17-year-old Josephine Sensont was discussed. Mayor Hector and Members Devine and Donahue adjourned the meeting until this morning at 5 o'clock, when the new details and several appointments were made. Mayor Hector after a few minutes' conversation said he was going out on the murder case himself and left in an automobile for the vicinity of the crime. Secretary Donahue told Captain Zaloudek that an order would be made this morning for the arrest of all pool hall hangers-on, bums and loafers out of work. Mayor Hector acquiesced in the announcement, but qualified the wholesale order to the extent that floaters should be picked up first.

A neighborhood report that the police were looking for a young man named Avery in connection with the crime caused the police to telephone the police that he would appear at the station without delay. He did so, and Mariano Sensont and James Bondi, who were with the girl at the time of the murder, stated positively that the young man was not one of those connected with the killing. Captain John Zaloudek, who has been working exclusively on the case, said last night that he had obtained a good description of the men. They were seen by several people, including one of the railroad watchmen. Zaloudek intimated that there would be some developments shortly if his clues proved of any worth. The men are said to have escaped by way of the O street viaduct, going in the direction of the horse barns of the Union Stock yards.

One Volunteer of More Use Than Five Drafted Soldiers

CARDIFF, Wales, Sept. 30.—(Via London).—At a big meeting here today, over which the earl of Plymouth presided, David Lloyd George, the chancellor of the exchequer, spoke of the government's decision to raise a Welsh army of 50,000 men. Mr. Lloyd George, who delivered a rousing speech, said that Glamorganshire already had recruited 24,000 and Monmouthshire 12,000 men. He frankly told his hearers that the recruits were not going out for a picnic, but for a stern enterprise which would involve hardships, wounds and danger, but he added, a vast majority would return and would have glorious memories to the end of their lives—memories they would not barter for all the gold in the Bank of England.

The chancellor of the exchequer pointed out that under conscriptions, Wales would be compelled to contribute 200,000 men, but that a volunteer army of 50,000 men would be just as good as a forced army five times that number.

AUSTRIANS LEAVE HUNGARY TO FATE

Continue to Retreat Toward Cracow to Join Right Wing of German Army.

WAY TO BUDAPEST IS OPEN NOW

Csar's Troops Within Ten or Fifteen Miles of Plateau, Where There Are No Fortifications.

LONDON, Sept. 30.—From the latest events in Galicia and along the Carpathians the conclusion drawn is that the Austrian army has abandoned Hungary to its fate and has left the route to Budapest to be defended by the Hungarian national troops," says the Petrograd correspondent of the Daily Telegraph. The dispatch continues: "The Austrians continue to retreat before the pursuing Russians and appear to have given up not only the defense of their country in general, but also to have decided to abstain from further independent action. They are simply hurrying on to Cracow to join the right wing of the Germans and apparently intend to become a mere component part of the German army."

Carranza Puts it Up to Conference; Says Villa Old Guard Tool

MEXICO CITY, Sept. 30.—In his reply this afternoon to the petition of Francisco Villa's generals, asking him to resign in favor of Fernando Iglesias Calderon and thus avoid civil war, General Venustiano Carranza says: "I will gladly take such action if it is ratified by the general conference; if I will fight with the same energy that I employed in combatting the usurpation of Huertismo."

Heavy Fighting Can Be Expected.

"It is officially announced at Vienna, according to a Rome despatch to the Exchange Telegraph company, that a junction has been effected between the new German army and the remnants of the Austrian army, which fought in the Galician battle. The new combined army is taking up a position and already has been in contact with the Russians along the Carpathian Tarnow-Cracow front.

J. I. TAMINOSIAN IS DISMISSED BY DANIEL

After arguing his own case before United States Commissioner Herbert S. Daniel, who took the matter under advisement, J. I. Taminosian, an Armenian rug dealer, has been discharged by the commissioner. He was charged in a government complaint with having attempted to influence a land case witness to leave the country. Commissioner Daniel decided that Taminosian's alleged actions occurred before government prosecution in the matter was started and that, therefore, he could not be held. When the government started the land case Taminosian became one of the principal witnesses for the prosecution.

ALFALFA AND CORN CROPS HARVESTED OFF SAME FIELD

Alfalfa planted in a cornfield in July and furnishing a crop of hay in September is a record made by Fred Rogers, superintendent of the county poor farm, which is astonishing farmers. The corn was used for roasting ears and fodder. On July 6 Mr. Rogers planted six acres to corn. Two weeks afterward he sowed alfalfa. The corn protected the alfalfa from the sun's heat and from washing due to heavy rainfall, according to Mr. Rogers.
