NEW YORK IN THE POWER BUSINESS

New York will invest \$170,000,000 in the generation of power on the St. Lawrence River and distribution of the product over State-owned lines to towns in Northern New York.

Thus, after 20 years, a battle in which the example of cheap power from the publicly owned hydro-electric plants of Ontario has fought sturdily upon the side of those who sought economic parity for the American side of the river, a project even greater than Muscle Shoals has moved to consummation in one of the states while the huge plant which Uncle Sam built on the Tennessee River lies virtually idle in the refusal of either Mr. Coolidge or Mr. Hoover to let the Government do what New York is doing upon the St. Lawrence.

The end of the long battle in New York came last Tuesday, and it was dramatic. The Republicans, who first fought against any State ownership and then sought to save the distribution of power to private capital, were forced to surrender on all fronts. The people in the district which is to be benefited by the project simply laid politics aside. They notified their legislators that unless they stood by Gov. Roosevelt, delegations would arrive in Albany to see that they did. That ended the fight. The opponents of State operation had struck at the last for a commission filed by the Assembly, and the Governor served notice that unless this power were placed in his hands he would veto the bill. The Albany correspondent of the New York Times, who has been consistently predicting that this is just what would happen, says that it is the final surrender. The Republicans opposed to the Governor's plan sat as silent as if their constituents had come down and gagged them.

The significance of this stirring drama will be twofold. The imprimatur of the Empire State will immensely stiffen the morale of all those in both the states and the nation who have assumed the offensive against the great predatory power industry. It will also add to the stature of Gov. Roosevelt in the forthcoming presidential election. If doubt arose as to his being worthy to wear the family crest at Armageddon, when he seemed not to be doing all he might to expose the corruption of Tammany, there is no uncertainty now as to his being another big game hunter. It was the power fight in New York that made Gov. Smith the Democratic nominee for President three years ago. When Roosevelt became Governor it was generally recognized that the power fight was to be his test and his opportunity. He proved himself indomitable. He risked failure rather than compromise, and he won.
