"The door of his house is always open to my husband," pressed for some hint as to when her suit would be filed, Miss Taylor said, "I have a feeling something will happen within 48 hours."
The actress said the charges she will make in her complaint will not be sensational.

"I will include as little as possible in the complaint," she said, "and I don't know yet whether I shall ask for alimony. A sensational divorce would injure my picture career, and I need to work. I must work to keep my mind occupied."
