**Bryan Says Charges 'Unfair and Unjust'**  
Governor Replies to State Senate Critics in the Genoa Bank Inquiry.  
Lincoln, June 22.—Governor Bryan today said charges made in the state senate Saturday concerning banking matters were "unfair and unjust."  
"The records will show beyond a possible doubt," Bryan asserted, "that the charges and insinuations made in the senate were malicious and without any foundation."  
The governor answered the charges with a long statement.  
The criticisms were to the effect that the governor had refused to issue a requisition for the return of L. A. Berge, wanted in a bank case; second, that he had refused to sign a complaint so that suit could be started against Van E. Peterson, former secretary of the guaranty fund

commission, and third, "it was insinuated that Governor Bryan had certificates of deposit on the Farmers' State bank at Genoa, to the disadvantage of the depositors of that bank."  
Bryan declared he had never had a formal request from a county attorney for requisition papers for Berge.  
He said the press of other duties had kept him from considering the Peterson case, but that he would do so and sign the complaint if circumstances warranted.  
The Genoa bank certificates of deposit, he asserted, came into his possession during a regular business transaction, and for them he paid their face value of 10 thousand dollars. It was his misfortune, he explained, that two years before he bought the certificates there had been alleged fraud in issuances of other certificates by the same bank.  
Mr. Bryan asserted his political enemies in the senate had taken advantage of their legislative immunity to make charges they would not state otherwise.
