Oil Station Robbers Held for Iowa Crime

Trio That Stuck Up Chester Welshimer in This City Face Charges in Iowa.

The identification of the two men and a woman who held up the Texaco oil station in this city ten days ago, as the same parties that are now held at Oskaloosa, Iowa, has been made, states County Attorney W. G. Kieck.

The parties were arrested at Oskaloosa by the authorities of that city and are charged with having committed a robbery at Chariton, Iowa, a short distance from Oskaloosa.

As the crime in Iowa will bring a more severe penalty than that given by the Nebraska laws, County Attorney Kieck states that they will be indicted in that state, but if escaping the Iowa charge will be turned over to Cass county for prosecution for the robbery in this city.

The parties were driving the Buick car that they used in the robbery here and a search of the car revealed the two sawed off shotguns that had been used in the Plattsmouth and Chariton robberies.

Death of Pioneer Resident of Cass County

Mrs. George Skiles Called by Death at Home in Murdock at Age of 84 Years.

Mr. and Mrs. George Skiles of Murdock and who have made their home at Murdock for many years have had their death angel visit their home on last Monday, claiming the life of the aged wife and mother, after they had journeyed together within a few weeks of sixty-five years.

Mrs. Helen Sarah Brown was born at Fort Madison, Iowa, on June 21st, 1848 when then the eastern portion of Iowa was a very new place. Just across the Mississippi river and five miles below, was the town of Novoo, headquarters of the Mormon church, eighty years ago. Miss Helen Brown was united in marriage to Mr. George Skiles on February 17th, 1867. They lived in happiness for nearly 65 years and would have celebrated the 65th wedding anniversary on the 17th of this month. The husband was born on April 15th, 1840.

The couple came to Nebraska in the early seventies and resided near Alvo for some time and came to make their home in Murdock in 1881.

Mrs. Skiles had not been in the best of health and passed away at 1:30 Tuesday, February 2nd, the funeral being held at the Murdock church, being conducted by the Rev. Hugo A. Norenberg of the Callahan church and the interment made at the Alvo cemetery, just north of that city.

During her life Mrs. Skiles was associated with the Methodist church there being no church of that kind at Murdock, the funeral was held from the Evangelical church. Those left to mourn the departure of this excellent woman is the aged husband, Mr. George Skiles, now nearing his 83rd birthday anniversary, two daughters and one son. The funeral was held Thursday of this week at 2:30 and the interment at Alvo the same day.

Recalls Scenes of Present Sino-Japanese Strife

L. B. Gorthy, Murdock Postmaster, While Serving in Navy Visited China and Japan.

The present China-Japanese warfare recalls vividly to L. B. Gorthy, postmaster at Murdock, his service in the U. S. navy, a large part of which was spent in the Asiatic waters. It was twenty years ago that Mr. Gorthy was in China and he remembers well the scenes where the present trouble is existing and where in his service the Chinese Imperial forces were battling the rebel forces that later overturned the monarchy.

On one of the expeditions he was on, was up the Yangtze river on board the U. S. Torpedo destroyer, Dale, where the Chinese and Japs are fighting now, the torpedo boat was patrolling the river protecting the American consul and missionaries. He was up the river about 275 miles, stopping at the following ports: Shanghai, Wu-Hu, Chin-Kiang and Nanking. While he was in Nanking the viceroy committed suicide.

The destroyer he was on, watched the Rebel and Imperial army fight from one fort to another and every once in a while they would see a dead Chinaman floating down the stream. On another occasion while he was ashore on duty, a Chinaman was beheaded. The head was hung up to a pole in the street and the body laid there on the ground. He did not happen to be there when the job was done, but was there shortly afterwards.

Other ports that he visited while serving in the navy were: Hakodate in Russia; Yokohama and Nagasaki in Japan; Manila, Olongapo and Carite in the Philippine Islands and Honolulu. Altogether he traveled about 25,000 miles by water.
