Legion Selects Boschult as New Commander

Lincoln Man Is Honored by State Meeting—Omaha Selected as 1936 Meeting Place.

Nebraska legionnaires Wednesday elected Edgar J. Boschult, commander of the Lincoln legion post, their state commander, at the state meet at Beatrice, decided to hold their 1936 convention in Omaha and adopted a resolution asking the WPA to change its rules so efficient workers can be given steady employment on its works.

Boschult was elected unanimously when George J. Hancock, district commander at Wauneta, withdrew from the race after tabulation of votes had started. Harry Kautz of West Point and A. J. Saville of Fullerton were elected vice-commanders and Rev. H. H. Marsden, Episcopal rector of Lincoln, was elected department chaplain.

Mrs. Armstrong Elected. Mrs. Robert Armstrong, Auburn, was elected president of the women's auxiliary and Mrs. Neil Krause of Newman Grove, retiring president, was elected national committee-woman from Nebraska. Mrs. Leah Bell of Lincoln was elected auxiliary historian.

Nebraska will have two candidates for national office at the legion convention in St. Louis next month. Both the legion and the auxiliary adopted resolutions supporting Mrs. Lorena Hahn, Wayne, for national president of the auxiliary.

The legion proposed Rev. George Jonaitis, Blair, for national chaplain. Featured speaker at the closing session was Harry Colmery of Topeka, Kans., a candidate for national commander. Colmery, active for years in legion work, is a former chairman of its national legislative committee.

Award Flood Citations. Hancock, commander of the legion district which did outstanding disaster relief work during the Republican river floods last June, was awarded a special citation for his heroism and bravery by the Nebraska department. H. H. Dudley, Lincoln, department adjutant, also announced the award of similar citations to families of six legionnaires drowned while engaged in disaster relief work in the valley. They are Glenn M. Anderson, Glenn C. Bell, Fred Swanson, Clark Colver, Ray Bickford and Fred E. Nordstrom.

Delegates at large to the national convention elected Wednesday are Fred Winter of Grand Island, retiring department commander; Boschult, Dudley, Marvin Meyers, of Falls City, Dwight Griswold of Gordon, Clinton Brome of Omaha and R. R. Sommerville of McCook.

Alternates at large are Robert Armstrong of Auburn, H. C. Fitzpatrick of Norfolk, Lloyd Kain of Lexington, George Fiala of Howell, Verne Taylor of North Platte and Paul Martin of Sidney.

"Prevent Injustice." The resolution directed at WPA pointed to its employment regulations by taking men from relief rolls and charged this system was unfair and discriminating against the "honest, hard working and efficient men." It urged the WPA to reconsider and change its regulations to prevent an "injustice" to efficient workers.

Another resolution asked that there be no limits on the CCC quota for veterans. Another move to make the Daniel Freeman homestead, near Beatrice, a national monument was launched by the legion as it requested such action by congress.

Another resolution recommended the construction of a new ward of 164 beds at the veterans' bureau hospital in Lincoln to care for insane war veterans.

Meet Church Challenge. Colmery told the convention it is time for the legion to meet the challenge of the church on the national defense issue. He urged adequate preparedness and said it is the duty of every American to take up arms in defense of his country if it becomes necessary. He said true Americanism is found in the great plains states which he described as the heart of the America negion.

Boschult, in the navy during the world war, is assistant purchasing agent of the University of Nebraska. He has been connected since 1919 with the university from which he graduated.
