Death of Franklin D. Hill

Franklin D. Hill, age 63 years, formerly of South Bend, Nebraska, but more recently a resident of Omaha, passed away Saturday, November 6, at St. Catherine's hospital in Omaha, following a short illness from pneumonia.

The deceased was born October 19, 1874, at South Bend, being a son of William D. Hill and Nancy Hill, both of whom were pioneers of Nebraska, where his father homesteaded in 1856 and resided until he moved to Omaha in 1904.

On November 27, 1901, the deceased was united in marriage with Lelah Kirkendall of South Bend. To this union four boys were born, two of whom, William Franklin and Ezra Floyd, died in infancy, and Martin Alvin and Jesse Lynn, who reside in Omaha. There are also two small granddaughters, two brothers, Jesse J. Hill, of Denver and Charles F. Hill, of Omaha, and one sister, Mrs. J. C. Kline of Fairbury, Nebr., together with a host of friends and acquaintances who mourn his passing.

Funeral services were held from an Omaha funeral home Tuesday, November 8, at 3 p. m., with interment in Forest Lawn cemetery by the side of his wife, who preceded him in death seven years ago.
