SENATE ASKS FOR THE FACTS

Mr. Culberson's Financial Resolution Adopted Without Division.

PENAL CODE BILL TAKEN

Chamber is Almost Decried and Call of the Senate is Made at the Request of Mr. Burkett.

WASHINGTON, Jan. 15.—The senate did not receive a reply today from the secretary of the treasury to its resolution concerning the financial situation, as had been pointed out in its absence Senator Aldrich assented to the passage of Senator Culberson's resolution on the same subject. The resolution was adopted by a vote of 54 to 24.

The senate passed a joint resolution reducing from \$100,000 to \$10,000 the real indemnity of the United States from China. The remainder of the session was devoted to the discussion of the penal code bill.

DR. C. BAETENS KILLS SELF

Musicalian Commits Suicide Day After Eighty-Second Birthday.

DIES BY BULLET IN BATHTUB

Known in This Country and Europe for His Ability as a Teacher and Player of the Violin.

Dr. Charles Baetens, veteran pianist and violin teacher, committed suicide Wednesday by shooting himself through the heart. The day before he had celebrated his eighty-second birthday, and increasing age, infirmity and insomnia are believed to have caused him to become despondent.

The shooting took place at 10 a. m. at the residence of Mrs. Joseph Withrow, 168 South Nineteenth street, where he had been rooming for some time. His wife and Mrs. Withrow were sitting in a downstairs room when they heard a shot. Going upstairs they found the bathroom door locked and could smell the fumes of burnt powder. They went out on the street and hailed a passerby, whom they got to crawl in the bathroom window and unlock the door. The doctor was found lying in the bathtub, clad only in a suit of underclothes and a white shirt. In the right hand was a .38-caliber revolver still warm from the shot.

Suffered from Ecema. For some time Dr. Baetens has been unable to attend his classes owing to his infirmity and ecema, from which he was a sufferer. This apparently preyed on his mind and caused him to become despondent and discouraged. His infirmities made it difficult for him to get about. He also suffered from insomnia and his friends believe this was a contributing cause to the act.

Dr. Baetens leaves a daughter and a son, Louis and Sidney, who live at 223 Chicago street. He was married the second time fifteen years ago to Miss Frances Smith, daughter of Alderman and Mrs. Peter Paul of Council Bluffs, former pupil. They have a daughter, Rogers. Mrs. Baetens for some time has been living with her parents in Council Bluffs, but owing to his infirmities and his fear of using the street cars Dr. Baetens has lived in Omaha.

Dean of Omaha Musicians. For years he has been known as dean of the Omaha musicians. Many of his pupils have written their names high on the scroll of honor in musical circles in different parts of the country. Among the local musicians of note who were formerly his pupils are Robert Casadesu, Emil Hoffman, Francis Albert, Daisy Higgins and Ernest Nordin, director of the local orchestra. Dr. Baetens was born at the Hague. When 4 years of age he began taking violin instruction from his father, who was a musician of considerable note. Before he was 11 years of age his musical ability attracted the attention of Inspector William I. of Brussels, who offered to send him to Brussels to study music. He went to Brussels and became the pupil of Charles De Broux, a violinist of much renown, and later studied with Felix de Brumelis, conservatory of music.
