

CHANGES IN CABINET

Numerous Shifts Necessary Ministry in Portugal.

BODIES WILL LIE IN SIGHT

Funeral of King and Crown Prince to be Saturday.

SERVICE IN MORTUARY CHAPEL

National Mourning Will be Observed for Three Months.

FRANCO SAID TO HAVE FLED

President Rumors that Ex-Premier Has Taken Refuge on Board British Ship—Republic at Oporto.

ON Feb. 4.—After several changes the new Portuguese cabinet has been definitely formed by Rear Admiral Ferreira de Amaral, as follows: Premier and Minister of the Interior—Rear Admiral Ferreira de Amaral. Minister of Public Works—Senator Carvalhosa. Minister of Marine—Vice Admiral Augusto de Castilho. Minister of Justice—Arthur Alberto de Campos Henriques. Minister of Foreign Affairs—Dr. Winston de B. Pereira. Minister of Finance—Manuel Alfonso. Minister of War—Sebastiao Custodio de Sousa Telles.

Service in Mortuary Chapel. A constant stream of prominent people called at the royal palace today to view the bodies of King Carlos and the crown prince, which are lying in an improvised mortuary chapel. A flood of soft light from countless candles filled the chamber of mourning, which was a mass this morning in the chapel, in which the members of the royal family were present and the priests, clad in sombre vestments, solemnly read the service for the dead. As the ecclesiastic in monotone murmured the Latin words of the credo and turned to offer the benediction soba broke from those in the room.

Bodies Will Lie in State. It was found the body of the king could not be placed in the casket secured for it, and arrangements were made for another. The bodies of the king and the crown prince will lie in state from early tomorrow morning to Friday night. The court chamberlains issued orders to keep watch over the bodies of the deceased ruler and his son. The vigil will continue day and night until the bodies are removed to the royal pantheon of St. Vincent for interment. The coffins repose in the center of the improvised chapel on a bier covered with rich black velvet upon which is embroidered a large white cross. At the head of the coffin of the king a royal crown, a crown covered with crepe, while at the foot lies the late king's sword and helmet. During the entire time the bodies lie in state the forts of the city and the warships in the Tagus will fire salutes at intervals of 15 minutes. National mourning will be observed by the court and public for three months.

Franco Still Missing. A public official said that Franco wanted to exercise even a more despotic power and that at the interview with the new king he said it was quite impossible for him to join the coalition movement. It was with eyes filled with tears that King Manuel finally accepted Franco's resignation. The former premier then hastily left the palace and had not been seen since. King Manuel then called for the monarchic leaders and named Admiral Ferreira de Amaral premier of the new cabinet. Queen Amelie herself issued orders to the military that the life of Franco should be carefully guarded.

Release of Prisoners Demanded. The progressivist-dissidents voted today to support the new government on condition that all political prisoners be freed; that all exiles be permitted to return to Portugal and their political rights be restored and that all existing autocratic measures contrary to liberty be repealed. Martial law and the suspension of constitutional guarantees was proclaimed yesterday, and the municipal authorities are taking the needed steps to prevent a recurrence of disorders. The palace and the public buildings are still guarded by troops and the police are in strong force on the streets. It has been officially denied that the revolutionary movement is spreading in Oporto or anywhere else in Portugal.

King Manuel, who was shot in the face and arm at the time his father and brother were assassinated, is improving. The Portuguese authorities still maintain a strict censorship on outgoing telegraphic news. There has been no recurrence of disorder in the city. It is persistently rumored that ex-Premier Franco, who was thought to have fled to Spain, has taken refuge on board a British cruiser anchored off Cascaes, fifteen miles west of Lisbon, and that by this means he plans to gain Gibraltar or England, where Dr. Jose Maria Alpoim, chief of the progressivist-dissidents, has fled from Portugal in an automobile. He disguised himself in order to be able to cross the frontier. He is now closely watching the course of events in Portugal from Salamanca, Spain.

BONI-HELIE CASE IN COURT

Adjourned Hearing of Controversy Comes Again to National Court in Paris.

PARIS, Feb. 4.—The Sagan-Castellane case came up in the correctional court today, having been adjourned from January 15. Count Boni and Count Jean de Castellane, his brother, are charged with assault by Prince de Sagan early in January. Answering a question put by the court, Count Boni declared that he could explain clearly the motives of his animosity toward Prince de Sagan by certain documents which he intended to hand over to the court, but that the intimate character of these papers preventing their being made public. At this statement Prince de Sagan interrupted the proceedings by crying in a loud voice: "These documents are forgeries."

NO RECORDS OF FURNITURE

Testimony in Harrisburg Trial Shows Policy Was to Buy and Charge It.

HARRISBURG, Pa., Feb. 4.—Having secured the admission of the bills, invoices and settlements and having shown that eight years ago Contractor J. H. Sanderson's only standard of measurement of furniture was the linear foot, the commonwealth today tried to show specific fraud in some of the items in the invoice at the trial of the capitol conspiracy cases.

EVIDENCE was also submitted to show that Sanderson's claim to a surface measurement standard in his bills for the furnishings for the new capitol was not sustained by any charges in his own invoices. To further illustrate to the jury that in paying for the capitol furniture the state was made to pay for its space, new exhibits of furniture and photographs of the rostrums in the senate and house caucuses rooms were filed in evidence. Sanderson collected \$90,718 and paid the subcontractor who made them \$2,000.

WASHINGTON, Feb. 4.—(Special Telegram.)—The nomination of B. F. Thomas to be postmaster at Omaha to succeed H. E. Palmer was sent to the senate today by the president.
