PROCEEDINGS OF THE SENATE Conference Report of Sundry Civil Bill Agreed To.

WASHINGTON, May 25 .- An effort to annihilate time by dilatory tactics, without making progress on any legislation except that involved the conference reports, was the chief occupation of the senate today under the leadership of Mr. Aldrich. The attempt was so successful that the net result in the way of accomplishment of the day's session was the adoption of the conference report on the sundry civil appropriation bill.

Throughout the day Mr. Beveridge was busy in an effort to get a vote on the bill compensating government employes for injuries received in the line of duty, but after the debate had progressed far enough to develop various objetcions to the language of the bill, Mr. Hale arose to say he had information from the house that no action could be expected there today on the conference report on the public buildings bill. and until that measure should be disposed of the deficiency appropriation bill could not be perfected, after which he moved an adjournment.

Mr. Beveridge resorted to some tactics to keep the senate in session to consider his bill, but Mr. Hale, amid laughter, remarked that "there are some things the senate can do without the consent of the senator from Indiana," and insisted upon a vote upon his motion.

The senate, at 4:40 o'clock, adjourned.

COURT FINDS THAW INSANE

Decision Given Under Which He Must Stay in Asylum.

JUDGE GIVES REASON FOR ACT

Finds Prisoner Menace to Society, Holding He Did Not Show Sanity in Trial When Possible.

POUGHKEEPSIE, N. Y., May 25 -Harry R. Thaw, the slayer of Stanford White, will not be released from the lunatic asylum. This is the decision reached by Justice Morschauser of the supreme court in an opinion filed early this morning in the matter of Thaw's application for release on a writ of habeas corpus. Both points brought up by Thaw's at-

torneys are decided against him. The justice declares that Thaw is now insane and should not be allowed at large, and he further declares that the commitment to the lunatic asylum by Justice Dowling after the last trial of the case was entirely legal. Prisoner Resigned to Fate. Thaw has accepted apparently

resignation the decision of Supreme Court Justice Morschauser that he is still insane and that the interests of the public will be best served by denying him liberty. Pending the signing of the papers of recommitment, which probably will not be done before a week from next Saturday. by Thaw's attorneys to induce District Attorney Jerome to consent to the commit ment of the prisoner to one of the state hospitals other than Matteawan. It is said that in the event of Mr. Jerome giv ing his consent to such a change no appeal will be taken from Justice Morschauser's decision. Even if an appeal were taken it could not be argued before fall. Decision of the Court.

Justice Morschauser's decision in part is as follows:

A writ of habeas corpus was allowed by which Harry K. Thaw was directed to be produced in court. In the petition it is alloged that Thaw was illegally imprisoned and restrained of his liberty by Amos T. Baser, acting superintendent of Matteawan State Hospital for the Insane.

Thaw's detention was attacked upon the grounds:

grounds:

First—That he is now sane.

Second—That the act under the provisions of which he was committed and detained is unconstitutional and the court was without jurisdiction to laste the order of commitment and such order was null and void.

I am satisfied from the evidence adduced before me that the mental condition of Harry K. Thaw has not changed and I find that he is now insane and that it is so manifest as to make it unsafe for him to be at large.

manifest as to make it unsafe for him to be at large.

Thaw had the opportunity on the trial to introduce evidence of his mental condition at that time, which he did not do. He should have known that the adjudication of the court would follow a verdict of nor guilty by reason of insanity; he was represented by able counsel, who urged the jury before whom he was tried upon a charge of homicide to acquit him because of his insanity.

Statute Not Passed Upon.

I have made a careful examination of the authorities and I do not find that this the authorities and I do not find that this statute has ever been passed upon by any of the courts in this state. It has been in existence and operation for many years without question, and it is the duty of the court to presume in favor of the validity of the statute until its violation of the constitution is established beyond all reasonable doubt, and upon such a determination the result which may follow from one construction or another is always a potent factor and is sometimes in and of itself conclusive.

In construing this statute it should be borne in mind that the safety and welfare of the community is of more importance than the freedem of the individual.

The relator claims that the statute does not provide a method by which Thaw can be discharged.

Section 20 of the insanity law provides: "Any inmate, not a convict, held upon an order of a court or tudge in a criminal

Any inmate, not a convict, held upon an order of a court or judge in a criminal proceeding may be discharged therefrom upon the superintendent a certificate of recovery, made to and approved by such court or judge."

Literature of the almanac variety proclaim in four languages the wonderful cureallativeness of the pills, assuring the prospective consumer that each and all the ills flesh is heir to will vanish when the pale green pellets enter the system.

When the samples were found in the yards of homes near the business district much indignation was aroused among parents, whose children were found in pos session of the packages. One child was discovered in the act of eating the pills and measures were instantly taken to prevent possible injury. Fortunately no harm resulted. The neighbors made every effort to find the distrbuter of the samples, but he could not be located, neither did the packages contain the name of any local druggist to whom the outrage could be traced. Had the distributer been caught with the goods he would have received a few lasting impressions of the indignation

of at least one lusty father. In this particular neighborhood, a few years ago, a family lost a child by precisely similar means and the memory of that sorrowful tragedy whetted the desire to catch and punish the author of the last 'out-

rage. One of the sample pills which rolled into a small hole in the sidewalk of one home was dissolved by Sunday's rain and left on the stones a blue-green blotch as large as a footprint in a mudpuddle. 
