#### ORACULAR WRITINGS REMAIN A MYSTERY

The Sibylline books were a collec tion of oracular writings in three volumes, said to have contained the fortunes of the ancient Roman date. According to tradition they were purchased by Tarquinius Superbus from the Cumaean Sibyl, and deposited in the temple of Jupiter Capitolinus at Rome in a stone chest, underground, They were guarded by certain officers, at first two in number, but afterward increased successively to ten and fifteen. The Sibylline books were not open to public inspection, but were consulted only by those in charge of them, at the special command of the senate. Whether they contained predictions or merely directions for propitiating the gods is difficult to deternine in consquence of the mystery that enveloped them. They were destroyed by the burning of the temple in 82 B. C., but a fresh collection was made and deposited in the same building when rebuilt. In 12 B. C. the Sibylline books were transferred by Emperor Augustus to the temple of Appollo on the Palatine hill, where ey remained until publicly burned by Stillcho, between 404 and 408 A. D.




