Sioux City Tribune, 14th: Within
a short time the voters of Woodbury
county and Dakota county, Neb, will
be asked to express their opinion of
the free bridge proposition, at a special
election, if the plans being worked up
by interested parties on both sides of
the river, are carried out. The propo-
sition will carry with it the issuance of
county bonds, the total sum to be di-
vided between both counties. The
South Sioux City Commercial club
has employed Keyes C Gaynor, for-
merly City engineer of Sioux City, to
do the preliminary work on the bridge
plans. When he has completed his
work, he will submit the outlines to
Wallace & Company, of Chicago. The
Wallace firm will prepare the blue
prints and make an estimate of the cost.
Mr Gaynor will make the neces-
sary surveys and soundings and select
the site. It is proposed to build a
bridge patterned after the two span-
ning the Mississippi river at
Dubuque, Iowa. It will be de-
signed for street cars, teams and
foot passengers. The bridge will be
28 or 30 feet wide, and 55 feet high,
thereby doing away with the necessity
of having draws to allow boats to pass.
At the present time it appears that
such a bridge would cost between
\$100,000 and \$200,000. It would not
be necessary to have heavy overhead
work as in a railroad bridge. Steel
caissons sunk and filled with concrete
would take the place of stone. Those
who are planning the improvement are
figuring on 24,000 square feet of ad-
vertising space to pay for the upkeep
of the structure. It is proposed to in-
stall crescent wood block pavement
and keep it in good repair. The bond
proposition would have to be approved
by the voters of both counties. Bonds
probably would bear interest at 5 per
cent. The Dakota county residents
are keen for the new bridge, as they
assert they are now obliged to pay
more than \$30,000 yearly for the priv-
ilege of using the old combination
bridge. In case the counties build
a new structure, they will be joint
owners and it could not be monop-
olized by a corporation. The site at
the foot of Pearl street looks most ac-
ceptable to those in charge of the
plan. Another location being investi-
gated is at the foot of Douglas street.
The last session of congress granted
South Sioux City a charter for the
building of a high wagon and street
car bridge. H U Wallace, of Chicago,
will be associated with Mr Gaynor.
He is a son of John F Wallace, who
was chief engineer of the Panama
canal.
