The Capital Issues Committee has legal jurisdiction over all issues in excess of \$100,000 and has requested that all issues of \$100,000 or less be submitted to the District Committee for approval.

It will be regarded as an unpatriotic not for any stock to be sold which has not received the permission of the Cupital Issues Committee, and all citizens are asked to cooperate with the Committee by refusing to buy any stock which has not been submitted to the Committee and received the proper permit.

#### Insist Upon Seeing the Permit Before Buying Any Stock

When you are asked to buy stock or bonds in any company, insist upon seeing the permit of the Capital Issues Committee for its sale. Do not accept any statement that it is all right, that the permit is in the of less of the company. DO NOT BUY ANY STOCK unless the proper permit is produced for your inspection.

Do not trade your LIBERTY BONDS for any stock, no matter if a permit for its sale has been issued or not. The boys at the front have enlisted for the duration of the War. Surely you should enlist your money without res-

You owe to the Government your co-operation in providing the money needed to carry on the War, and the Capital Issues Committee helps you to avoid non-essential invest-

Please do all that you can to assist the Government in this direction.
