M. E. Church Notes Rev. S. A. Draise, Pastor The "World Program Convention' held in Omaha during February 11th and 12th was the event of greatest interest to all Methodist churches of the Omaha area. It is one of a series of sixteen similar gatherings which are being held in all parts of the United States for the promotion of the Centenary world program of the church. This world program is a celebration of the one hundredth an-niversary of the missionary activi-tics of the church. It includes in its scope the developement of systematic prayer and stewardship habits among the Methodist people, the building of

parts of the world; the training of 10,000 new pastors, missionaries, deaconesses and religious teachers annually; and a general reorganization of the Methodist church to meet the new world conditions. The carrying out of this program is expected to involve the expenditure of about a hundred million dollars within the next five years-over \$1,000,000 of this will be spent in Iowa and Nebraska. 
