



> Chile is very near the enactment of a law similar to the Eighteenth amendment to the United States constitution, waiting only for a little further observation of the result of the prohibitory law here, and 'to develop a little more assurance in the minds of those engaged in the wine industry that grapes may be grown with profit without the liquor industry. Both government officials and educators are lined up strongly for prohibition, and the prophecy is that another five years will see Chile dry. The young students who are being financed here by their government are being placed in different parts of the country, under different environment, and it is expected that their observations will be useful in helping Chile to come to a clear understanding of the effects of prohibition on the industrial and social life of the people and upon the public health. The three young women have been placed in the special charge of Miss Anna A. Gordon, president of the W. C. T. U. in the United States.
