

Article 1-Name.

#### Article IX Quorum.

A majority of the members of this association in good standing shall constitute a quorum to transact bus-iness; a majority of the members of the board of directors shall constitute a quorum to transact business in the directors' meetings.

#### Article X-Indebtedness

No indebtedness shall be contracted or liabilities incurred by this Association in excess of the cash the hands of the Treasurer of in the Association,

Article XI Amendments

This constitution may be amended by three-fou-ths vote of those present at any regular meeting or any called meeting, provided the amend-ment proposed is stated in the call.
