Snow Fireplaces in Alaska. Sixty degrees below zero is the frightfully cold atmosphere in which Alaska gold hunters must often work They make fireplaces of snow in that desolate region. The snow is pressed into blocks like bricks, and a fireplace two or three feet square is built with them. A snow fireplace used only for cooking purposes will last for an entire winter.

## Sallor's Wide Trousers.


