

Air Dome for Alliance

Work was commenced Monday morning on Burroughs & Schellak's new air dome between the Horace Bogue and the Bee Hive stores. These two brick buildings, 50 feet apart, will furnish the sides, while a metal front 15 feet high will enclose it from the street on the north side. The dimensions of the auditorium will be 50 by 50 feet, exclusive of the stage which will be on the south side and in addition to this space. It will have a seating capacity double that of the opera house and will probably be a great convenience at the time of the stockmen's convention in June and for other similar occasions during the summer. It will have a canvass cover, something that air domes do not always have. It will be finished as soon as possible, probably about the first of pext week.
