 The following proposed amendment to the constitution of the State of Nebraska, a hereinalter set forth in full, is submit-ied to the electors of the State of Nebraska, to be voted upon at the general elec-tion to be held Tuesday, November 3rd, A. D. 1914.
 "FOR a Joint resolution to amend section 1 of Article 9 of the Constitution of the State of Nebraska, relating to revenue.

 Section 1. That Section 1 of Article 9 of the Constitution of the State of Neb-traska be amended to read as follows:
 Sec. 1. The rules of taxation shall be uniform as to any given class and taxes shall be levied upon such property as the exemptions may be provided, in addition to those hereinafter specifically mentioned in section 2 of this article.

That at the general election in November, 1914, there shall be submitted to the electors of the state for their ap-proval or rejection the foreigoing proposed amendment to the Constitution in the fol-lowing form: "For amendment to the Constitution providing for uniform and progressive taxation" and "against said proved and progressive and reasonable exemptions may be provided. In addition to those hereinafter specifically mentioned in section 2 of this article.

# PROPOSED CONSTITUTIONAL

PROPOSED CONSTITUTIONAL AMENDMENT NO. TWO. The following proposed amendment to the constitution of the State of Nebrase. as hereinafter set forth in full, is submit-ted to the electors of the State of Nebrase. A. D. 1914. "A Joint Resolution to amend Section six (6) of Article one (1) of the Const-tution of the State of Nebraska. Be it Enacted by the People of the State of Nebraska:

of Nebraska: Section 1. That Section six (6) of Article one (1) of the Constitution of the State of Nebraska be amended to read as follows: follows: Section 6. The right of trial by jury shall remain inviolate; but in all civil cases and in criminal cases less than felonies, five-sixths of the jury may render a verdict and the Legislature may authorize trial by a jury of a less number than twelve men in courts inferior to the district court.
