

# LIVE STOCK PRICES AT SOUTH OMAHA

Beeves 10 to 15c Lower and Best Feeders Steady.

TRADE IN HOGS IS STEADY.

Sharp Break in Lambs, Prices Being 20c Below Friday and About Steady With Thursday—Fat Sheep Nearly Steady—Weaker Tone to Feeders.

Union Stock Yards, South Omaha, Sept. 14.—A rather liberal run of cattle arrived yesterday, some 10,000 head. The few corned steers on sale sold rather unevenly and at prices that looked quite a bit lower than a week ago. Quality of the range cattle was very fair. Reports from outside markets were not very encouraging and dressed beef men were slow in getting started. Bids on some of the more desirable cattle were not so very much lower than the latter part of last week, while on the general run of grass beef bids and sales looked all of 10@15c lower. Some right good heavy beeves brought \$8.15. Cows and heifers were generally not far from steady with the latter part of last week, and the trade in stock cattle and feeding steers was fairly active and not far from steady.

About 4,000 hogs showed up yesterday. While the market was rather dull, prices were just about steady with the close of last week. Most of the packing hogs sold at \$6.60@6.90, with heavies running on down, and a sprinkling of lights and butchers clear up to the top, \$7.70.

Sheep and lamb receipts totaled 42,000 head. The market turned out to be another all forenoon session, but sellers could not offset the effect of the heavy run, and when the offerings finally started scaldward buyers had pretty much their own way, the bulk of the good fat lambs selling at \$8.40, which is 20c under Friday's market, or about steady with the price paid last Thursday. There was a slightly lower trend to feeding lambs, prices ranging anywhere from steady in some cases to a dime lower in others. Feeding and breeding ewes were in good demand and while the trade was pretty well supplied, prices showed little change. Fat sheep were pretty close to steady.

### PICK SEED CORN EARLY.

1. Pick seed corn before October 1st, 1915.
2. Pick at least five times as much as needed.
3. Hang in dry, well-ventilated place.
4. Hang so ears will not touch each other.

### CORN WORK FOR SCHOOLS.

The Schools Should Help in the Movement to Save the Seed Corn for Next Year.

Do not assign lessons by bulletins and booklet. Teach by things, not words. Then we shall be teaching the boy and girl and not the subject.

Let the pupils go into the field and select what they consider good ears of corn. Now, look them over for strong and weak points.


They haven't been told what to look for? True—but let us not tell them; let us work it out together.

Shell off half the corn from two or three ears, keeping that from each ear by itself. Measure the amounts and compare them. Can you tell by looking at the half-shelled ears why one ear produces a larger amount of shelled corn than another ear of apparently the same size?

We must examine the kernels more closely. Some are too short, some taper too much, some are chaffy. Some will not drop evenly in the planter.

### EXAMINE THE KERNELS

DON'T SELECT SEED CORN BY SIMPLY LOOKING AT THE EAR



Ears should be of medium size, not too long nor too short. If they are too long they are likely to mature late; if they are too short, they will mature too early and will not produce as large a quantity of corn. Ears which are too large around are late maturing and are likely to have too much cob; while ears which are too slender will not yield a large amount of corn.

Now we know what sort of an ear is best for seed, but why should we select it so early and why gather it from the field? This is so we may select as seed, corn which matures early. In short seasons, when the frosts come late in the spring or early in the fall, a late maturing corn will not ripen for seed. We should have corn which we are sure will ripen before the frosts. You understand, of course, that if frost touches the corn before it ripens, the germ may be destroyed and this corn will not grow.

When it is late enough so that all the corn is ripened, we cannot tell which ears ripened early; so we will go into the field early and gather our corn, selecting that which is already matured.

Then we must know the type of stalk on which the ear grew. Study bulletins and articles on selecting seed corn and let the schools lead the county in this movement vital to the country's corn crop next year.

The Agricultural Extension Department of The International Harvester Company issues a special school bulletin on selecting seed corn from the field which is sent for the asking.

### POOR SEED MEANS A POOR STAND.

If Every Ear of Corn Intended for Planting Was Harvested at the Proper Time, and Properly Stored and Tested Before Planting, Millions of Dollars Would Be Added to the Value of the Corn Crop Every Year.

Corn growers should remember that poor seed is the chief cause of a poor stand, and that a poor stand means a small yield. It means missing hills, weak stalks producing little or nothing. It means less than 30 bushels per acre instead of 60. It means that we produce on an average, just one small ear of corn to each hill instead of two or three. It means wasted land and wasted labor.

### BAD PLACES TO STORE SEED.

1. Stable over or near stock.
2. Over oats or corn.
3. Damp cellar.
4. Closed attic over kitchen.
5. Any damp, closed place.
6. Out in the sunshine.

### What is "Show Corn"?

At a corn show one often hears the expression, "I have plenty of good seed corn, but I haven't any show corn." The best seed corn and the best show corn should be the same, and the object of the judge at a corn contest, and of a farmer selecting his seed to plant, should be the same. In each case the most profitable ear is the one desired.

The people of the lower half of Sheridan county find it necessary to make a two hundred mile trip in order to get to their county seat and back and want to end the waste of time and money.

The annexation plan would be less expensive, and the big, new court house at Alliance would well serve the business interests of the entire territory. The lower six tiers of townships could be taken from Sheridan county and added to Box Butte very easily.
