




# Only About Half the Steer is Beef

## WAR BUDGET FOR WAR WORK

State Fuel Administrator John L. Kennedy Unable to be Present, but Sends Interesting Message

John L. Kennedy, of Omaha, Nebraska fuel administrator, who was to speak at the commercial club convention Wednesday morning on the subject, "A War Time Budget for War Work in Nebraska," was unable to be present but he was ably represented by Arthur L. Palmer, of Omaha, who after a brief talk, read the following message from Mr. Kennedy:

"The legislature of its next regular session should make an adequate appropriation, or authorize a direct levy for war purposes. In lieu of that counties and cities throughout the state might be authorized to create funds for such purposes, for use in their own communities. Both plans might be followed to advantage. The proceeds of the direct appropriation or levy by the state could be used under the supervision and direction of state officials to be named in the act; the proceeds of appropriations or levies made by county or city authorities to be expended by county and city officials. Several other states have made appropriations.

"In all branches of war work the need for money for expenses will constantly increase.

"Ample provision should be made for carrying on the work of the state and county councils of defense, and for conducting the Red Cross, liberty bond, war savings, thrift and other campaigns. Then there are many local expenses in connection with the food and fuel administrations which should be absorbed by the several communities.

"Up to this time, these expenses have been met largely by voluntary contributions from patriotic citizens. In that way, the same people contribute over and over again, and sooner or later their capacity to give will be exhausted. Then, too, the great majority of our people do not now pay any part of the expenses of these campaigns. This deprives them of an opportunity to help along those lines. All our people should contribute and co-operate, and their interest in all war activities would thereby be increased.

"There are other obligations which we should be prepared to meet promptly and cheerfully. Young men have gone to the front, leaving dependent families behind them. In most instances provision has been made for them. Circumstances change, however, sickness comes, earning capacity is reduced, children are born and bring with them additional expenses; and by and by some of the soldiers will come home to be cared for. Nebraska certainly cannot afford to fall behind other states in meeting these conditions. It will be a great relief for the men at the front to know that their state and their communities stand solidly behind them and their families in any and every emergency. Soldiers' families should be made to feel that it is a privilege for us to give, and an honor for them to receive, such assistance. We who stay at home should be glad to share in the honor and the glory which will come to our country when the war is won.

"If the convention should adopt resolutions on this subject, a committee might be appointed to act with other committees, which may hereafter be named by other organizations, to confer with the legislature. This would be a direct method of gathering and presenting to the members much necessary information. In the meantime, public sentiment should be aroused to the necessity for legislative action."
