Be it Resolved by the Legislature of the State of Nebraska:

PROPOSED CONSTITUTIONAL

AMENDMENT

Section 1. That Section One of Article Seven of the Constitution of the State of Nebraska be and the same

hereby is amended by striking out the following words:

"Second. Persons of foreign birth to be transacted by the corporation is who shall have declared their inten- to buy, lease or otherwise acquire tion to become citizens comformably to the laws of the United States. on the subject of naturalization, at least thirty days prior to an election."

And inserting in the place of the words so stricken, the following words:

"Second. Persons of foreign birth who shall have become citizens of the for pipe lines, side tracts, telephones, United States by naturalization or otherwise conformably to the laws of the United States at least thirty days prior to an election.


Sec. 2. That at the general election nineteen hundred and eighteen (1918) there shall be submitted to the electors of the state for their approval or rejection the foregoing proposed amendment to the constitution relating to the right of suffrage. At such election, on the ballot of each elector voting for or against said proposed amendment, shall be written or printed the words: "For proposed amendment to the constitution relating to the right of suffrage," and "Against said proposed amendment to the constitution relating to the right of suffrage.

Sec. 3. If such amendment shall be approved by a majority of all electors voting at such election, said amendment shall constitute Section One (1) Article Seven (7) of the Constitution of the State of Nebraska. Approved, April 9, 1918.





ARTICLE V The highest amount of indebted-

ness or liability to which the corporation may subject itself shall not exceed an amount equal to two-thirds (2-3) of its paid-up capital stock. ARTICLE VI.

The corporation shall date from and commence on the 19th day of September, 1918, and shall terminate on the 19th day of September, 1968. However, this corporation may be dissolved at any time prior to its own limitations, by consent of twothirds (2-3) of the paid-up and outstanding capital stock of said corporation by a resolution dissolving the corporation spread upon its records and certified to the Secretary of State.

ARTICLE VII. The business affairs of the corporation shall be conducted by a Board of Directors consisting of not less than tiree (3) nor more than five (5), and the officers by them to be elected, as hereinafter provided.

ARTICLE VIII. The voting power of the capital stock of the corporation shall be, one vote for each share of capital stock issued by the corporation.

ARTICLE IX. The first annual meeting of the stock holders of the corporation shall he held in the City of Alliance, Nebraska, on the first Monday in January, 1919, and the regular annual meeting of the stock holders


shall be held in the City of Alliance, Nebraska, on the first Monday in January of each succeeding year. At said first meeting, and at the

annual meetings thereafter the Board of Directors shall be elected by the stock holders from their own number, to hold office until the annual meeting next after their election and until their successors shall have been elected and have qualified.

The undersigned incorporators shall be and constitute a provisional Board of Directors, who shall conduct the affairs and business of said corporation until the first annual meeting on the first Monday in January, 1919, and until their suc-

cessors shall have been elected and have qualified. ARTICLE X. The Directors shall, in each in-




