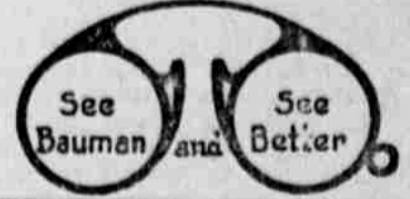
UNNEEDED, UNWANTED

McKelvie, Governor of the State of Nebraska,** by authority of law in me vested, do hereby direct and proclaim that a special election be held in the several polling places throughout the State of Nebraska on Tuesday, the twenty-first day of September, 1920, during the hours designated by law for holding General Elections for the purpose of adopting or rejecting said proposed amendments.
