The deceased came to North Platte over twenty years ago, and with the exception of a short period had resided here continuously. Local physicians failed to render assistance and he was sent to the sanitarium but he gradually grew worse until death came to his relief.

**The Convict's Daughter.**

The confidential clerk of a southern banker reveals in villiany, lying and forgeries because he is the rejected suitor of his adopted daughter. He wins distinction as a conspirator and hypocrite. He shows his noble nature by allowing the villian to be banished. His daughter is told the secret of her history and is wedded to the young man she loves.
