A JOINT RESOLUTION to amend Sec-tions two (2), four (4), five (5), six (6) and thirteen (13) of Article vix (6) of the Constitution of the State of Ne-braska, relating to Judicial Powers. Be it Resolved by the Legislature of the State of Mebraska: Section 1. Amendment proposed. That Section 1 two (2) of Article six (6) of the Constitution of the State of Nebraska
